**Invitation to a Seminar on “Participating in ADB’s Future Carbon Fund”**

The Asian Development Bank (ADB) established in 1966, headquartered in Manila, Philippines and owned by 67 member countries, including the United States and Canada, announced the concept of a Future Carbon Fund (FCF) back in July 2008. The FCF is a public-private partnership, and carbon procurement fund, to generate credits beyond 2013, the post-Kyoto period.

The FCF, operated by ADB as a trustee, will finance renewable energy and energy efficiency projects in ADB’s developing member countries in Asia and the Pacific. ADB has already received commitments for approximately half of the total fund size of US\$200 million from several nations, and is currently seeking participation from the private sector, i.e. final users of carbon credits, for the remaining half.

ADB’s climate change team will be in Washington, DC in January and will be hosting an event at the Brookings Institution on 28 January to discuss opportunities for participation in the FCF. Your presence would be greatly appreciated if your firm is interested in participating in FCF. Should that be the case, please complete the attached form by Wednesday, 21 January 2009.
