

**THIRTY-SEVENTH ANNUAL MEETING
ATTENDANCE OF NONGOVERNMENT ORGANIZATIONS (NGOs)**

1. The NGO Center is writing to the members of the Board of Directors, requesting their assistance in bringing the attached list of NGOs to the attention of their respective Governments. Through a practice adopted in 1995, NGOs endorsed and accredited to a past Annual Meeting retain endorsement and accreditation on a no-objection basis. We therefore seek, on this basis, Governments' endorsement to accredit the listed NGOs from their respective countries for the Thirty-Seventh Annual Meeting in Jeju Island, Korea. The list includes NGOs that were given accreditation to attend the 36th Annual Meeting.
2. The primary purpose of NGO attendance at Annual Meetings is to create an opportunity for NGOs to learn about ADB's operations and engage in consultation and dialogue with other Annual Meeting participants, including members of the Board of Directors, Management, senior staff, and members of country delegations from ADB member countries.
3. NGOs attend Annual Meetings with the registration status of "NGO". Guidelines for NGO attendance at Annual Meetings have been established, and are communicated to NGOs along with the confirmation of their accreditation.
4. ADB requires that NGOs attending Annual Meetings be accredited in advance. The NGO Center coordinates the accreditation process. The NGO Center also supervises NGO-related matters during the period of the Annual Meeting, including administrative arrangements and physical facilities. The Office of the Secretary is responsible for inviting and registering participants from the accredited NGOs.
5. A requirement for NGO accreditation is endorsement by the Government of the country in which the NGO is based. Endorsement or otherwise is accomplished through the Board of Directors, with NGO requests to attend the Annual Meeting being forwarded to the appropriate chair for necessary action.
6. Endorsement and accreditation being retained on a no-objection basis was adopted to streamline the endorsement and accreditation process. Through the no-objection arrangement, Governments and ADB retain the option of revoking endorsement or accreditation. It is proposed that the arrangement remain in place for the Thirty-Seventh Annual Meeting. NGOs not accredited to a previous Annual Meeting are required to go through the complete endorsement and accreditation process, as mentioned in para 5.
7. Upon request, the NGO Center will provide members of the Board of Directors the list of NGOs to which Annual Meeting invitations are sent as well as a list of NGOs who have indicated interest in attending. Should members of the Board of Directors wish that announcements be sent to NGOs not on the list, names of the additional NGOs can be forwarded to the NGO Center for necessary action.

8. Objection to any NGO previously endorsed to an Annual Meeting retaining the endorsement, as listed in the attachment, should reach the NGO Center through the Office of the Secretary by 1 December 2003. Names and contact information for NGOs that the Board of Directors wishes to be informed of the Annual Meeting should reach the NGO Center by the same date.
