Operations Updates, 2009^a

Sovereign Lending

ADB has approved this year 15 loans to 7 developing member countries totaling \$1.84 billion. Approved loans from ADB's ordinary capital resources (OCR) total about \$1.5 billion, while \$343 million came from ADB's concessional Asian Development Fund (ADF).

Nonsovereign Operations

ADB has approved six nonsovereign projects worth \$550.82 million.^b

Grants

ADB has approved 16 grant-financed projects totaling \$160.9 million, and 84 technical assistance grants worth \$73.06 million.

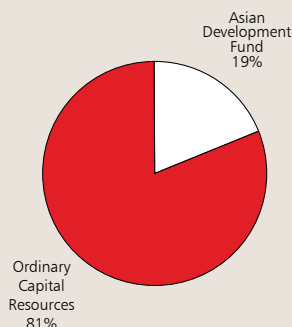
