Through technical assistance project for capacity building to manage risks, Asian Development Bank Resettlement Project (TA6091-REG) conducted an auditing on the road construction project, however, our problems have not been addressed.

- We would like to request the Director to undertaken develop project process in a way that people are not affected by it.

We will submit other additional documents in addition to this grievance complaint.

We would like the Director to respond to me both in Khmer and English.
