Project Description

The overall objective of this TA is to diagnose problems and recommend solutions that will lead to the sound financial management and accounting of monies in NWSDB. The more specific objectives will be (i) to assess and advise on professional accounting staff adequacy and competency; and (ii) to assess and advise on financial and accounting procedures and practices in NWSDB.

The objectives of the TA are to assess and initiate community-based opportunities for income generation and poverty reduction through (i) detailed assessment of the supply and demand for credit requirements for project beneficiaries for investments in productive activities; (ii) the preliminary rehabilitation of existing credit unions through institutional strengthening; and (iii) detailed assessment of options for development of the microfinance sector in East Timor, including the feasibility of establishing a microfinance bank.

Project Description

The objectives of the TA are to evaluate the efficiency of ongoing Fiji Development Bank (FDB) performance, procedures, identify the operational obstacles, provide recommendations for its improvement in the future to best match with the Government development perspectives, to

make FDB financially self-sustainable and function well while observing the sound banking practices. More specifically, the TA will: (i) provide an overall review of FDB present activities and recommend possible changes; (ii) identify its operational obstacles in terms of funding resources; (iii) analyze its credit and profitability status; (iv) review FDB Act and other legal documents; and (v) provide recommendation on strategic development plan for its future activities which meet the Government objectives.

Project Description

The immediate objective of the TA is to complete the preparation of a Project which will support the Government's development and implementation of a more effective, environmentally sound locust control program beginning in the 2001 crop year. A secondary objective is to promote the refinement and effective implementation of MOA's longer-run strategy for locust management in order to contribute to a sustainable capacity for preventing such emergencies in the future. The TA's scope will include: (i) field surveys of local locust control facilities, practices, and institutional capacities in a sample of severely affected oblasts; (ii) community consultations to ascertain existing knowledge, attitudes, and practices in regard to locust control; (iii) analysis of technological alternatives for locust control, including their relative costs, benefits, and environmental implications; and (iv) preparation of the detailed Project implementation plans, cost estimates, financing arrangements, and environmental monitoring and institutional development requirements.

Project Description

The TA will be the first study explicitly focusing on poverty in the country. The study aims to assist the Government in (i) preparing a Poverty Analysis including a Poverty Profile, Responses to Poverty to Date and Poverty Reduction Options based on existing though limited data and information at both national and local levels; (ii) undertaking consultation with stakeholders on the Poverty Analysis; (iii) providing inputs to the High-Level Forum; and (iv) establishing a Partnership Agreement with ADB.

6. Establishing a Public Private Joint Venture for the West Bengal North-South Economic Corridor Development, India

Project Description

The TA will assist the Government of West Bengal in the establishment of the institutional prerequisites for building a relationship based on trust between the public and private sectors for the overall purpose of developing the economic corridor. This is necessary to ensure that sufficient high-level project management skills are in place from 2000 onwards to oversee and expedite all aspects of the investment implementation process.

The objective of the TA is to assist the Government in maintaining the social focus of agricultural research during the move to commercialization. Towards this end, the TA will identify research that requires public funding versus that which can be commercialized, provide recommendations on the types and forms of public funding necessary to maintain a strong agricultural research system, and identify the role of foreign assistance in the agricultural research system with specific recommendations for ADB's potential partnership with the Government in this endeavor.

Project Description

The TA will support preparation of the Decentralized Health Services Project. The objectives of the TA are to identify strengths and weaknesses, at the central level and in selected provinces, to decentralization of health services according to Government policy and regulations; and to help develop a strategic plan to support the decentralization process. Specifically, TA resources will be used to (i) collect, summarize and analyze information and data related to health services decentralization and identify critical shortages and needs; (ii) help prepare implementation plans and strategies to efficiently decentralize health services in selected provinces; and (iii) assist selected provinces to identify local resources and local needs with beneficiaries participation, and

prepare a local plan of action for decentralized health services. Several aspects need to be considered: laws and regulations; systems and procedures; economic and financial resources for health services; health services management and financing (including integrated health planning and budgeting); human resources for decentralized health services; participation of the community and the civil society; accountability and transparency; and benefit monitoring and evaluation.
