The project was designed as a sector loan with environmental, involuntary and indigenous people's safeguards incorporated through frameworks. # DESCRIPTION

ADB's loan assistance includes support for: (i) rehabilitating damaged sections of state and district drainage structures, construction of bridge connections to replace temporary crossing arrangements and new bridge crossings on evacuation routes for future disasters; (ii) rehabilitation and reconstruction of ports and harbors; (iii) rehabilitating and upgrading village and municipal roads, drainage canals, public buildings, electrical networks; and ADB's grant assistance includes support for: (i) restoring the livelihoods of the affected people with focus on poor and low-income households through self help groups (SHGs) supported by NGOs; (ii) restoring and upgrading damaged rural and municipal water supply systems; and, (ii) capacity building and project implementation.
