1. Overview

1.1 Project background

The Northeast GMS corridor (includes Nam Ninh, Quang Tay province, China; Hanoi and Thanh Hoa of Vietnam; Louangphrabang of Lao and Bangkok of Thailand) has been considered as importance corridor as pointed out in the GMS Transport Development Strategy and the Connective between the Northeast of Lao and Northern of Vietnam. Many sections of the Corridor are still under good condition or have been upgrading. An example of The Northern GMS Transport Network Improvement Project has been approval in 2007, which consist of 370 km under the Lao's Northeast Corridor; main component is NH No. 4 connective from Louangphrabang to Lao – Thailand border. However, the remaining sections under Corridor the Northeast of Lao to North of Vietnam border must be upgraded to ensure the connective of the whole corridor.

The Second Northern GMS Transport Network Improvement Project focuses on the HN 217 of Thanh Hoa province in the northern of Vietnam and NH 6, 6A and 6B of Houaphanh province in the Northeast of Lao. Finally, the Nghi Son port will play a role as the main gate to the sea of the corridor. The government of Vietnam and Lao are strongly support for upgrading these connective routes to promote the economic development along the Northeast GMS Corridor and facilitate the connection between Northern of Lao with seaport all the year (including rainy and flood seasons). This project belongs to the Area Implementation Cooperative Action Plan in 2010-2012.

This project is to improve access to social services and markets (leading to improved livelihoods and poverty reduction) and improve the efficiency of the road network and transport in the project area and sub-region. The project will improve the ability to connect the sub-regions and create favourable link among Thailand, Vietnam and Lao. The road works will improve international and regional connectivity through improving traffic quality and constructing bridges and water drainage systems. The project will include new construction and replacement of weak bridges, upgrading and rebuilding severely damaged roads and minimizing influence of flood. The routes will provide convenient connections to districts' centre, national highway and improvement of traffic safety.

The Project is supported by ADB for i) upgrading of National Highway 217 section from Km107+200 - Km195+400 (approximately 88 km in length) to graded IV mountain road standard; ii) new construction of 2 bypasses of Cam Thuy town (Cam Thuy East and West Bypasses with total approximately 3 km in length) to graded III road standard; and iii) improvement of road surface of the section from Km0+000 - Km104+900. The Thanh Hoa PPC will support PMU1 to implement resettlement plan.




Figure 1: Project location

1.2 A brief of Updated RPs

The Second Northern GMS Transport Network Improvement Project - Upgrading of National Highway No. 217, Thanh Hoa province, phase 1 is implemented in Cam Thuy district, Ba Thuoc district and Quan Son district, Thanh Hoa province.

Cam Thuy bypasses include Cam Thuy East bypass and Cam Thuy West bypass. The Cam Thuy East bypass is 1.58 km in length, starts at Km 54+750 on NH217, goes through agricultural land areas and intersects with Ho Chi Minh road at Km 522+100 (equivalent to Km 56+330 of NH217). Cam Thuy West bypass is 1.39 km in length, starts at Km 523+750 on Ho Chi Minh road (equivalent to Km 58+560 on NH217) and connects with NH at Km 59+950.

Highway No.217 goes through Quan Son and Ba Thuoc district has the length of 88,7 km from Km107+200 to Km 195+400, in which section in Quan Son district is 75,4 km from Km 120+250 to Km195+400 and section in Ba Thuoc district is 13,3 km from Km 107+200 to Km120+250.

Because the Project goes through 3 districts, there are 3 separate updated RPs for the 3 districts. According to the URPs, the implementation project have been affected to land, trees, crops, structures... of HHs/agencies. These impacts are summarized in tables below:

Moreover, URP also mentions to some impacts on trees, crop, and some public assets.

1.3 Outline of independent monitoring on RP implementation

The donor, ADB, requests that the implementation of RP must be followed with the approved RP to ensure social safeguard of the project, all the gaps (if any) during the implementation of RP should be considered and identified for coming tasks such as updating resettlement plan, additional compensation activities or design of income restoration programs for APs. This requires feedback channels on the implementation of RP. Besides internal monitoring report on RP implementation prepared by Project Management Unit (daily monitoring), the donor also requests a different objective and independent channel, referred to the external monitoring report which is prepared by an external agency, not directly under the Project Management Unit.

1.3.1 Independent monitoring agency

The external monitoring agency must understand clearly about social safeguard policies of donors and of regions. They are qualified, have sufficient human resources to undertake this task. The association of Investment and Environment Protection Consultation Company EPC (EPC Co., LTD.) and Center For Assisting Community Sustainable Development (CSD) is one of the agencies which meet the above conditions and have been selected by the investor for this service.

1.3.2 Monitoring and reporting compliance monitoring implementation of RP 3rd

According to the signed contract, Independent monitoring agency have to perform: (i) Inception report; (ii) Baseline survey conduct and report preparation on social-economic condition of Cam Thuy district - Progress report No. 1; (iii) Preodic compliance monitoring report - Cam Thuy district - Progress report No. 2 - Semi-annually report; (iv) Baseline survey conduct and report preparation (baseline) on social-economic condition of Ba Thuoc and Quan Son districts (- Progress report No. 3); (v) Periodic compliance monitoring report - Ba Thuoc and Quan Son district - Progress report No. 4 - annually report; (vi) Periodic compliance monitoring report for whole project- Progress report No. 5 - Semi-annually report 2; (vii) final report.

Up to now, the independent monitoring agency has completed report (i), (ii), (iii), (iv) and (v). This report is periodic compliance monitoring report for whole project-Progress report No. 5 and use the results by IMA surveyed in 12/2014.

1.3.3 Objectives of independent monitoring

Independent monitoring on the RP implementation is to assess:

If the implementation of the resettlement plan have been followed the policies and procedures outlined in the RP or not;

If the main objective outlined in RP, that the living standards of the affected people will be at least restored or even improved, is achieved;

Identify gaps between the actual situation and indicators of RP; make recommendations if any;

Monitoring reports are to assess and make recommendations for the completion of the RP and for the RP implementation measures in accordance with the actual conditions to ensure that risks of worse living, livelihood, production, income, etc. due to the land acquisition for the project are minimized.

- At PMU 1 office;
- Resettlement Committees of Cam Thuy district, resettlement of Quan Son and resttlement of Ba Thuoc district.
 - Interview affected households in communes.

1.3.7 Sample size selection

Sample size for interview according to TOR and selected in the inception report includes: (1) 20% of partially affected households, (2) 100% of severely affected HHs¹. Sample size in this monitoring will be shown as table below:

¹Severely affected HHs are the HHs to be relocated or lost more than 10% of agricultural land

3. Results/Findings

3.1 RP implementation Arrangement

The Resettlement activities has been considered as an subproject, Thanh Hoa PC was assigned for Quan Son and Ba Thuoc districts to carry out the RPs of the project's section passing their area. Cam Thuy, Quan Son and Ba Thuoc DCARBs had been established. The DCARB members include i): General deputy of district PC; ii) managers/deputy managers of district's Industry and Trade Division, Environmental and Natural Resource Division, Finance and Planning Division, iii) Chairman and land management officers of affected communes and 2 representatives of affected villages.

The results from site survey show that, NH217 is not the first project that need to resettle in the districts, but it is the first project which funded by OAD loan. Therefore, almost DCARB member have not fully understood on the difference between the donor's safeguard policies and Vietnam requirement. Thus monitoring consultants also indicated several differences (i) Information disclosure requirement (ii) Require compensation cost at replacement prices which leading to require an survey and the compensation replacement cost for each project; (iii) DMS and IOL; (iv) independent monitoring requirements. Full understanding on requirements of compensation implementation between donor's policies and Vietnam regulations will be very useful in RP preparation and implementation.

The DCARB members are representatives of involving departments of district, of affected communes and of the affected people. In spite of holding concurrently mechanism, the DCARB has worked very effectively in preparation of compensation plan, compensation payment, land acquisition and resolution of complaints. However, with such mechanism, the storage of compensation plan was not good. At the time, each department is responsible for storing records of their management fields only. For example, DONRE is responsible for storing documents on measurement, inventory, calculation and compensation plan while Finance and Planning department is responsible for storing vouchers and invoices of compensation payment. That may affect the accuracy of payment and cause difficulties in the internal and external monitoring.

3.2 Information disclosure

The information disclosure about the RP is particularly paid attention to as mentioned in the policy framework of the project. It is to make sure that all AHs are entitled to participating in and being consulted sufficiently. If information is disseminated well, AHs can understand thoroughly about the RP. Thus, it will reduce complaints as well as ensure progress of the project. Status of information disclosure is represented in the table below:

Remark: The information disclosure was sufficiently done, which included information disclosure on detail compensation plan to AHHs before submitting for

approval, which could be considered that transparency during RP preparation and implementation. Almost interviewees have been provided information about the project and compensation policies.

3.3 Checking sufficiency of the entitlements

To check sufficiency of the entitlements, the consultant focused on following issues: (1) Validity of compensation records, (2) Quantitative sufficiency of compensated assets; (3) Sufficiency of compensation cost and (4) Assistance policies.

3.3.1 Validity of compensation records

One set of compensation record include at least following papers: (1) Decision on land acquisition; (2) DMS minute; (3) Compensation calculation sheet; (4) Payment minute. To check validity of a compensation records, the consultant paid attention to the 4 above documents, sufficiency of signatures and stamps of stakeholders, validity in time order of different papers, etc. Details of the review are as follows:

Through checking record, it reveals that all the compensation records were valid

3.3.2 Quantitative sufficiency of compensation assets

Checking the quantitative sufficiency of compensated assets is to ensure that all affected assets have been inventoried, measured and compensated. To check quantitative sufficiency of compensated assets, the consultant paid attention to: (1)

Comparison of quantity of inventoried assets with one in the detailed compensation plan; (2) Interview HHs on satisfied level with number of compensation assets and(3) Complaint letters on requesting supplementary inventory.

Result of checking DMS shows that all DMS minutes were clear and with sufficient signatures of stakeholders. Among those, the signatures and name of AHs have been filled clearly and sufficiently. The number of affected assets in DMS minutes is consistent with the number in detailed compensation plans. There were no complaints or suggestion letters about supplementary or insufficient inventory. In sum, the affected assets have been inventoried and calculated sufficiently in term of quantity.

3.3.3 Checking on compliance of compensation cost and assistance allowance

According to RP of compensation cost plan, affected assets must be applied by replacement cost. To check sufficiency in term of compensation cost, consultant concentrated on issues below:

(i) Legal bases for calculating compensation and assistance

Applied documents for calculating affected assets' compensation and assistance are as below:

- Decision No. 3788/2009/QD-UBND dated 23 October 2009 of Thanh Hoa province PC on stipulating policies of compensation, assistance and resettlement in the event of land acquisition by the State in Thanh Hoa province;
- Decision No.1745/2013/QD-UBND dated 28 May 2013 of Thanh Hoa province PC on replacement cost of land for land acquisition of the project Upgrading of National Highway 217 (NH217) in Quan Son district;
- Decision No.1666/QD-UBND dated 22 May 2013 of Thanh Hoa province PC on replacement cost of structures for land acquisition of the project Upgrading of National Highway 217 (NH217) in Quan Son district;
- Decision No.1667/QD-UBND dated 22 May 2013 of Thanh Hoa province PC on replacement cost of trees and crops on land for land acquisition of the project Upgrading of National Highway 217 (NH217) in Quan Son district;
- Decision No.1665/QD-UBND dated 22 May 2013 of Thanh Hoa province PC on approval of assistance rates for land acquisition of the project Upgrading of National Highway 217 (NH217) in Quan Son district;
- Decision Bo.1273/2013/QD-UBND dated 18 April 2013 of Thanh Hoa province PC on replacement cost of land for land acquisition of the project Upgrading of National Highway 217 (NH217) in Ba Thuoc district;
- Decision No.1525/QD-UBND dated 10 May 2013 of Thanh Hoa province PC on replacement cost of structures for land acquisition of the project Upgrading of National Highway 217 (NH217) in Ba Thuoc district;

- Decision No.1293/QD-UBND dated 22 April 2013 of Thanh Hoa province PC on replacement cost of trees and crops on land for land acquisition of the project Upgrading of National Highway 217 (NH217) in Ba Thuoc district;
- Decision No.1571/QD-UBND dated 16 May 2013 of Thanh Hoa province PC on approval of assistance rates for land acquisition of the project Upgrading of National Highway 217 (NH217) in Ba Thuoc district;

The analyses above show that the legal bases for calculating compensation and assistance are the documents (i) new documents issued in 2013, only document stipulated assistance spending issued in 2009(ii) Compensation assets based on replacement cost survey.

(ii) Comparison of compensation cost in reality with one in RP

In order to considering legal bases for calculating compensation and assistance for this project, the consultant also compared compensation cost in reality with one in RP for assessing the sufficiency of the compensation cost. Results of the comparison are as follows:

It can be seen that compensation cost in reality is not significantly different from one in RP.In addition to compensation according to RP, HHs received assistance

allowance for shifting job that was 1.5 time of agricultural land cost. AHs interview on the difference between compensation cost and market price, 94.09% of AHs agreed on compensation cost for agricultural land, 89.56% of AHs agreed on compensation cost for trees/crops. This is the high agreement rate from AHs. For compensation cost of residential land, however, 26.23% agreed with compensation cost and 49.18% thought that compensation cost was low. Detail of HHs interview on the remark of compensation cost is as below:

(iii) Comparison of compensation cost in reality with one in RP

In addition to considering legal bases for calculating compensation and assistance for this project, the consultant also compared compensation cost in reality with one in RP for assessing the sufficiency of the compensation cost. The compensation costs for land, structures, trees and annual crops are equal to the cost in RP.

Satisfactory level of AHs with compensation assistance cost: the consultant interviewed some HHs about satisfactory level with compensation assistance cost. Results shows that about 620/670 APs (equal to 88.6%) that was satisfactory with compensation assistance cost.

Through analysis above: (i) compensation cost for affected assets applied was replacement cost; (ii) compensation cost in reality was equal to price in RP; (iii) There was no complaint about price and; (vi) AHs was satisfactory about compensation cost, so the project considered that it had complied with sufficiency of compensation cost.

3.4 Compensation plan disclosure

The detail compensation plan had been announced to each AHs for checking any missing assets, reference before approval. Moreover, these plan also issued the information disclosure at public broad in all comments officers within project area. After that DCARB invited all APs to attend the information disclosure meeting and

consulted with the detail compensation plan for each AH. At this meeting, all AHs will sign on their detail compensation plan if they agree with the plan. The AHs disagreed to sign would have 15 days for consider their complains. During this time, the member of DCARB together with commune PC representative will visit these AHs house to identify, explain and complaint address. Following this mechanism which could create high transparency during preparing and approving RP and got high acceptance of local people with the detail compensation plan leading to high satisfy with compensation cost and project policy.

3.5 Checking the timeliness of the compensation

According to the RP, all affected assets must be fully compensated before the land acquisition, concretely as follows:

- Compensation for fully affected house must be done at least three months before land acquisition;
- Compensation for agricultural land must be done before the construction;
- Compensation for trees and annual crops must be done before the construction.

All the interviewees said that they have been fully compensated before the land acquisition. No interviewees had to hand over their land before receiving compensation. The analysis shows that the timeliness of the compensation was complied with.

3.6 Complaint and Complaint Address

Main complains concentrated on 3 issues: (i) Affected asset inventory that is still inefficiency;(ii) Disagree how to calculate compensation area for structure, housing that was partly affected; (iii) AHs located within the ROW land must be replaced their houses who request for replacement assistance.

- + For the AHs who missed the affected assets, the DCARBs has been carried out calculated again, finally, these APs are total agree with the results.
- + For the AHs who still disagreed with calculate method for area and physical structure which is partly affected. The DCARBs also could not decide that the remaining house structure whether safety enough or not for living, thus the DCARBs asked the Department of Civil Work and Construction for assisting.
- + For the AHs who living within the ROW, and not affected on residential land but still need to remove the house, request for replacement assistance policy. However, there is no policy for these causes, the DCARBs also sent the request to Thanh Hoa PC for further consideration.

It is quite clear that all complain cases have been considering. For such steps, it will get high agreement when detail compensation plan has submitted for approve. All complains have been resolved.

3.7 Number of relocated HHs and resettlement area

a) Number of relocated HHs

Although much mitigation measures have been taken into account during RP preparation to reduce land acquisition area, number of relocated HHs and impacts on local people but there are still a number of HHs need to relocate for project implementation.

4. Conclusion

Through the RP monitoring, we can conclude that the RP implementation has been complied with the approved RP, this reveals through following issues:

1. The information disclosure of subprojects has been complied with requirements of RPs. The information disclosure has been done many times and with many types;

- 2. All affected assets have been inventoried, calculated and compensated for AHs. Most of interviewees participated in the DMS and signed minutes of asset inventory;
- 3. Compensation cost is replacement cost and has been agreed to by all AHs. Besides, the interview on satisfactory level of AHs with compensation cost also shows that almost interviewees agreed to the compensation cost;
- 4. Timeliness of the compensation has been complied with involuntary resettlement policies of ADB. All AHs have received full compensation before handing over the sites for the project;
- 5. All the problems mentioned in the last supervision was solved by DCARBs;
- 6. At the time, no activities involving to income restoration programs have been done in Cam Thuy district, Ba Thuoc district and Quan son district. According to officers of district Women Association, Farmer Association, Agricultural Extension Centre, Forest Extension Centre and Vocational training centre, they did not know information and their roles in the implementation of income restoration programs.
