We, who have signed this letter, are residents of *PO PARAS TEHS. BALAKOT DISTT. MANSEHRA PAKISTAN* and would like to file a complaint regarding the *BALAKOT HYDROPOWER DEVELOPMENT PROJECT* having Project no; 49055-007, an ADB-assisted Project.

We believe that due to this Project, we have suffered or are likely to suffer the following:

- They are going to award the Affectees by force by following the Land acquisition act 1894 and totally ignoring the ADB safeguard Policy statement.
- The local administration and PEDO force Affectees to give up their lands and buildup structures under compulsory acquisition
- They are evaluating the land, which needs to acquire for the project, under OSAT (average value by mutation) system.
- The valuation of buildup structures is calculated under MRS (Market rate system) 2018
- The PEDO executed the socio-economic survey by un-professional and untrained staff
- The local administration and PEDO are totally ignoring the ADB Policy and human fundamental rights

We have previously raised our concerns with the *project specified ADB concerns representative who visited once, with the PEDO and with the Local administration*, but the Affectees are not satisfied with the outcomes.

Hence, we choose to solve the problem with the Special Project Facilitator (SPF).
