Subject: Request for land for resettlement to be compensated by the Royal Railway;

Reason: We, poor residents, have no other piece of land to build a house for resettlement and we have lost the location where we do our business to support our daily living.

With regard to the above subject, we would like to request the Office of Special Project Facilitator (OSPF) to intervene so that we are provided with a piece of land each to construct a house for resettlement.

***Note:** We have filed our complaints to the village chief, the Sangkat chief and the governor of Poipet municipality, Banteay Meanchey province, on March 23, 2011, and we were informed by the municipal governor that he would arrange for the matter to be resolved for us. However, we have not seen any working group coming to do anything for us since then.

Now, the Poipet Municipal Hall has issued a letter ordering all of us to move.

In reference to the above information, we would like to request the Head of the Office of the Special Project Facilitator (OSPF) to help settle the matter for us accordingly.

Please be informed that our houses are entirely (100%) affected; though, the working group conducting the survey compensated only the cost of moving, and it is written in the payment receipt that we have to move our houses backwards when we have no more space to move the house backwards.

We, therefore, humbly request the head of the OSPF to help render justice for us in a time manner as we have been ordered to move very soon.
