## **I. INTRODUCTION**

1. The Ministry of Education and Training (MOET) is implementing the Second Upper Secondary Education Development Project (USEDP II, or the Project) in the 33 provinces of Viet Nam, through Loan № 2929 – VIE (SF) from Asian Development Bank. Under the Project, a total of 135 upper secondary schools (USSs) and six (6) pedagogical centers have been selected for assistance. In the screening and categorization for social safeguards, Category A subprojects are automatically excluded, while Category C subprojects shall be prioritized for financing. The subproject USSs with minor impacts (Category B) may be considered subject to the preparation and implementation of a resettlement plan (RP) acceptable to ADB, as prescribed in 2009 Safeguard Policy Statement (SPS). The RP for Category B subproject shall be approved first by the Bank and disclosed in the ADB website before implementation by MOET.

2. In Nghe An Province at the Central part of Viet Nam, eight (8) USSs are hereby endorsed for the Project, namely: (i) Ky Son Ethnic Minority Boarding Upper Secondary School; (ii) Do Luong 3 Upper Secondary School; (iii) Quy Hop Upper Secondary School; (iv) Nghi Loc 5 Upper Secondary School; (v) Quy Chau Ethnic Minority Boarding Upper Secondary School; (vi) Tan Ky Upper Secondary School; (vii) Con Cuong Upper Secondary School; (viii) Anh Son 3 Upper Secondary School. They are located in eight districts of the Province. As screened, they are all Category C subprojects both in Involuntary Resettlement and Indigenous Peoples categorization (Attachments 1 to 8), since no social impacts are expected inside the schools' premises. The Central Project Management Unit (CPMU) of USED P II has submitted this Due Diligence Report (DDR) for information of ADB and to secure its "No Objection" for the award of civil works contract for the construction of school facilities.

## **II. APPROACH AND METHODOLOGY IN DUE DILIGENCE**

3. The CPMU has applied the selection criteria in evaluating the USSs included in the long list. The criteria were developed during the PPTA. Given the large number of USSs and their geographic locations, the CPMU sent questionnaires to be filled-up by school officials whose responses were the basis for screening and selection in producing the shortlist of USSs. The school officials of shortlisted USSs were then given two sets of questionnaires. The first set was used in gathering information on their proposed facilities and statistical data that justify their proposal. The proposed investments were then screened and made the reasonable distribution of facilities that are urgently needed. The second set was aimed to validate if land acquisition shall be required. National resettlement specialist and CPMU Civil Work Assistance conducted site survey and consultation with key officials of the Nghe An PPMU and proposed schools during 28-29 January 2015 to verify information provided by the Nghe An PPMU.

## **III. THE PROPOSED FACILITIES**

4. In all, the eight (8) USSs will construct 48 regular classrooms and twelve (12) function rooms for the classes in biology, physics, chemistry, and laboratory. The construction of regular classrooms will follow the standard dimension as provided for in Decision № 37/2008/QĐ-BGDĐT (July 16, 2008) by MOET. The following dimension of each classroom is as follows: length = 7.8 m and width = 9.9 m. Comprising the width is 7.5 m working area and 2.4 m for the corridor. Each classroom shall have a total area of 56.77 m<sup>2</sup>.

5. The function rooms shall have the following dimensions: length = 11.7 m and width = 9.6 m. The length shall be composed of 7.8 m for working area and 3.9 m for preparation room of teacher. The width is composed of 7.5 m for activity room and 2.1 m for the corridor. Overall, each function room shall have a total area of 83.92 m<sup>2</sup> in which 56.47 m<sup>2</sup> for activity room and 27.45 m<sup>2</sup> for preparation room of the teacher.

6. The distribution of the proposed facilities in eight (8) schools is shown in Table 1.

#### IV. BRIEF PROFILE OF THE USSs

##### A. Ky Son Upper Secondary School

7. The school became operational in 1967 and was established in Block 4, Muong Xen Sub-Town, Ky Son District. The school serves 01 sub-town of Muong Xen and 20 communes of: Ta Ca, Nam Can, Tay Son, Na Ngoi, Nam Can, Bao Thang, Bao Nam, Huu Lap, Chieu Luu, Huu Kiem, Pha Danh, Huoi Tu, Bac Ly, My Ly, Keng Du, Na Loi, Dooc May, Muong Long, Muong Tip, Muong Ai.

8. The School has 19,010 m<sup>2</sup> of land with only 3,763 m<sup>2</sup> are used for school buildings and other structures. During the school-year 2013-2014, a total of 1,517 students were enrolled, 867 are males and 650 are females. The students were composed of 586 from Grade 10, 482 in Grade 11 and 449 in Grade 12, and belong to different ethnic groups like Kinh being the small share (4.4%).

9. With more than 40 years in operation a number of school structures including classrooms were not in proper condition that prompted the school official to request for 12 classrooms. It has 102 personnel, eight (8) are non-teaching staff and 94 are teachers, in which 72 are Kinh while 22 are EMs. The teachers are all graduates of universities with five (5) teacher have already a master degree while six (6) are pursuing theirs.

##### B. Do Luong 3 Upper Secondary School

10. The school was established in 1978 in Village 11, Quang Son Commune of Do Luong District. It serves nine (9) communes of Tinh Son, Hoa Son, Tan Son, Thai Son, Quang Son, Thuong Son, My Son, Minh Son, Xuan Son. The school premises occupies a total of 27,444 m<sup>2</sup> of land covered by Land Use Right Certificate BN 104996. Of the total lands, 2,789 m<sup>2</sup> are used for school buildings.

11. During the school-year 2013-2014, some 1,424 students were enrolled, 773 are males and 651 are females. Enrolment comprised by 462 students from Grade 10, 471 in Grade 11 and 493 in Grade 12. All students are Kinh. The average enrolment student of the school in the last five years is 1,425.

12. With more than 35 years in operation some structures of the school became old and degraded which prompting the school officials to request for six (6) additional classrooms and three (3) function rooms from MOET. The school has 87 personnel, six (6) of which are non-teaching staff and 81 are teachers. All teachers are graduates of universities with nine (9) teachers have master degrees as one (1) is still pursuing for the same course.

### **C. Quy Hop Upper Secondary School**

13. Established in 1968, the Quy Hop USS occupies a total area of 24,600 m<sup>2</sup> of lands in Tay Ho block of Quy Hop sub-town of Quy Hop District. About 3,650 m<sup>2</sup> are occupied by school buildings and serves the Quy Hop sub-town 19 communes of Yen Hop, Chau Tien, Chau Hồng, Đồng Hợp, Châu Thành, Liên Hợp, Châu Lộc, Tam Hop, Chau Cuong, Chau Quang, Tho Hop, Minh Hop, Nghia Xuan, Chau Thai, Chau Dinh, Van Loi, Nam Son, Chau Ly, Hạ Son, Bac Son.

14. During the school-year 2013-2014, enrolment was totaled to 1,136 students consisting of 582 boys and 554 girls. A total of 385 students were enrolled in Grade 10, 372 in Grade 11 and 379 in Grade 12. The Kinh shared majority with 68.8% and Thai, 31.2%.

15. Guiding the students were 65 teachers, 32 are males and 33 are females, where 62 are Kinh as three (3) are EMs. All teachers have university education, three (3) have their master degrees as three (3) are pursuing similar graduate course. The school has ten (10) non-teaching personnel.

### **D. Nghi Loc 5 Upper Secondary School**

16. The school was established in 2006 in Village 5, Nghi Lam Commune of Nghi Loc District. It serves communes of Nghi Lam, Nghi Van, Nghi Kieu, Nghi Hung, Nghi Dong, Nghi Cong Nam, Nghi Cong Bac. The school premises occupies a total of 28,204 m<sup>2</sup> of land covered by Land Use Right Certificate 17848.20.90. Of the total lands, 6,579 m<sup>2</sup> is used for school buildings.

17. During the school-year 2013-2014, some 1,122 students were enrolled, 547 are males and 548 are females. Enrolment comprised by 380 students from Grade 10, 367 in Grade 11 and 375 in Grade 12. All students are Kinh. The school average enrolment student during the last five years is 1,425 student.

18. The school has 71 personnel, seven (7) of which are non-teaching staff and 64 are teachers. All teachers belong to "Kinh" group and graduate of universities with (15 teachers have master degrees as five (5) are pursuing for the same course.

### **E. Quy Chau Upper Secondary School**

19. Established in 1965, the Quy Chau USS occupies a total area of 25,000 m<sup>2</sup> of lands in Tan Thinh block, Tan Lac sub-town of Quy Chau district. About 2,800 m<sup>2</sup> are occupied by school buildings and serves the Tan Lac Sub-Town and communes of Chau Hanh, Chau Hoi, Chau Binh, Chau Phong, Chau Hoan, Dien Lam, Chau Nga, Chau Thang, Chau Tien, Chau Thuen, Chau Binh.

20. During the school-year 2013-2014, enrolment was totaled to 1,243 students consisting of 543 boys and 700 girls. A total of 459 students were enrolled in Grade 10, 375 in Grade 11 and 409 in Grade 12. The Kinh shared 33.3%, Thai 66% and Tho 0.7%.

21. Guiding the students were 86 teachers, 40 are males and 46 are females, where 55 are Kinh as 31 are EMs. All teachers have university education, eight (8) have their master degrees as three (3) are pursuing similar graduate course. The school has ten (10) non-teaching personnel.

### **F. Tan Ky Upper Secondary School**

22. The school was established in 1965 in Block 6, Tan Ky sub-town of Tan Ky District. It serves Tan Ky Sub-Town and 15 communes, namely: Ky Tan, Nghia Dũng, Nghia Hop, Nghia Hanh, Tan Long, Nghia Hoan, Nghia Phuc, Tan Huong, Dong Van, Tien Ky, Phu Son, Tan Huong, Nghia Binh, Tan Hop, and Giang Son

23. The school premises occupies a total of 28,800 m<sup>2</sup> of land and only 2,235 m<sup>2</sup> land are used for school buildings. During the school-year 2013-2014, some 1,603 students were enrolled, 740 are males and 863 are females. Enrolment comprised by 511 students from Grade 10, 551 in Grade 11 and 541 in Grade 12. The Kinh student present majority with 98.4% and the other EMs groups of Tho, Thai and Thanh shared the remaining with 1.6%

24. With nearly 40 years in operation some structures of the school became old and degraded and which prompting the school officials to request for three (3) function rooms from MOET. The school has 102 personnel, seven (7) of which are non-teaching staff and 95 are teachers. All teachers are graduates of universities with 20 have master degrees and 04 are following their master courses.

#### **G. Con Cuong Upper Secondary School**

25. Established in 1967, the Con Cuong Quy USS occupies a total area of 12,240 m<sup>2</sup> of lands in Block 5, Con Cuong Sub-Town of Con Cuong District. About 1,864 m<sup>2</sup> are occupied by school buildings. The School students from Con Cuong Sub-Town and communes of Bong Khe, Yen Khe, Chi Khe, Chau Khe, Cam Lam, Lạng Khe, Binh Chuan, Don Phục, Mau Duc, Thach Ngan, Tam Son

26. During the school-year 2013-2014, enrolment was totaled to 1,174 students consisting of 563 boys and 611 girls. A total of 412 students were enrolled in Grade 10, 340 in Grade 11 and 422 in Grade 12. The Kinh student presents the big share with 53% and the Thai present 45.4%.

27. Guiding the students were 88 teachers, 41 are males and 47 are females, where 73 are Kinh as 15 are EMs. All teachers have university education, nine (9) have their master degrees as one (1) is pursuing master course. The school has 5 non-teaching personnel.

#### **H. Anh Son 3 Upper Secondary School**

28. The school became operational in 1976 and was established in Village N<sup>o</sup> 2, Dinh Son Commune, Anh Son District. The school serves seven (7) communes of: Tho Son, Binh Son, Thanh Son, Tam Son, Dinh Son, Cam Son, and Tuong Son.

29. The School has 17,842 m<sup>2</sup> of land as per Land Use Right Certificate No. CT11277 and CT11282. The School has used only 1,930 m<sup>2</sup> land for facilities.

30. During the school-year 2013-2014, a total of 917 students were enrolled, 478 are males and 439 are females. The students were composed of 323 from Grade 10, 290 in Grade 11 and 304 in Grade 12, and belong to the Kinh with 95% and Thai with 5%

31. The School has 69 personnel, four (4) are non-teaching staff and 65 are teachers of the Kinh group and 28 are males and 37 are females. The teachers are all graduates of universities with seven (7) teacher have already a master degree.

## V. ASSESSMENT OF SOCIAL IMPACTS

32. There are no social impacts expected arising from land acquisition in any of the selected USS in Nghe An Province. The school premises are enclosed with concrete or wooden fences as protection from encroachers, and neither a house nor structure of private person was allowed by the school administration. Given the total land requirements of the proposed facilities, they were assessed as to their impacts on available lands in the respective school premises.

- **Ky Son Upper Secondary School.** This school proposes 12 classrooms in a 03-storey building. The structure will be built in the area of 460 m<sup>2</sup> within the existing school compound. No land acquisition is required and no third-party user will be affected.
- **Do Luong 3 Upper Secondary School.** This school proposes for 06 classrooms and three (3) function-rooms in a 03-storey building. The structure will be built in an area of 454 m<sup>2</sup> within the existing school compound. No land acquisition is required and no third-party user will be affected.
- **Quy Hop Upper Secondary School.** This school proposes for 06 classrooms and three (3) function-rooms in a 03-storey building. The total land for the building shall be 438 m<sup>2</sup>. The structure will be built within the existing school compound of 24,600 m<sup>2</sup>. No land acquisition is required and no third-party user will be affected.
- **Nghi Loc 5 Upper Secondary School.** This school proposed nine (9) classrooms in a 03-storey building. The total land for the building shall be 352 m<sup>2</sup>. The structure will be built within the existing school compound of 28,204 m<sup>2</sup>. No land acquisition is required and no third-party user will be affected.
- **Quy Chau Upper Secondary School.** This school proposed nine (9) class-rooms in a 03-storey building. The total land for the building shall be 360 m<sup>2</sup>. The structure will be built within the existing school compound of 25,000 m<sup>2</sup>. No land acquisition is required and no third-party user will be affected.
- **Tan Ky Upper Secondary School.** This school proposed three (3) function-room in a 03-storey building. The total land for the building shall be 328 m<sup>2</sup>. The structure will be built within the existing school compound of 28,800 m<sup>2</sup>. No land acquisition is required and no third-party user will be affected.
- **Con Cuong Upper Secondary School.** This school proposed three (3) function-room in a 03-storey building. The total land for the building shall be 326 m<sup>2</sup>. The structure will be built within the existing school compound of 17,842 m<sup>2</sup>. No land acquisition is required and no third-party user will be affected.
- **Anh Son 3 Upper Secondary School.** This school proposed six (6) class-rooms in a 02-storey building. The total land for the building shall be 343 m<sup>2</sup>. The structure will be built within the existing school compound of 17,842 m<sup>2</sup>. No land acquisition is required and no third-party user will be affected.

33. With the foregoing information on the proposed subprojects in Nghe An Province, request for “No Objection” for the award of civil works contracts is being sought by MOET from ADB.
