The proposed project will meet an increasing consumer demand for safe high value food crops by establishing a modern value chain by: (i) constructing value chain infrastructure for a safe food chain, particularly collection centers linked to a distribution center; (ii) improving the capacity of farmers and agro-enterprises involved in the value chain through accreditation of value chain actors in good agricultural practices and hazard analysis and critical control point; and (iii) facilitating adoption of new technologies by farmers and agro-enterprises by providing to finance. The impact will be consumers and producers benefit from improved production, handling and processing of safe high value crops to Dhaka markets is enhanced. The impact will be improved health, nutrition and family planning status of the urban population, particularly the poor, women, and children. The outcome will be sustainable good quality urban primary health care services in the project areas and target beneficiaries are made available. The TA will: (i) assist the Government of Bangladesh to design the additional financing project; (ii) undertake thorough due diligence; and (iii) ensure project readiness.

The IT/IT enabled-service (ITES) industry faces several challenges for accelerated industry development. These include: (i) adequate physical infrastructure to create synergy among firms and attract investment; (ii) well-trained human resources and innovation capacity; and (iii) strategic interventions to support Bangladesh IT/ITES' integration with the global value chain. The government has already taken initiatives including developing a number of IT parks to address the constraints in physical infrastructure. Currently, two parks, Kaliakoir Hi-Tech Park and Jessore Software Technology Park, are being developed with public-private partnership, partly supported by the World Bank. ADB's support will augment the ongoing development in the two IT parks by providing research and development facilities and business incubation centers, strengthening IT education and training, and supporting the government to develop and implement IT/ITES industry-enabling strategies. Different models will be explored and developed for replication in the other IT parks planned by the government. The TA will: (i) review and analyze past and existing studies relevant to all subprojects including the current master plans of Kaliakoir Hi-Tech Park and Jessore Software Technology Park; (ii) develop master plans; (iii) prepare feasibility studies for each candidate subproject; (iv) identify issues in environment, climate changes, and social safeguards for project development; and (v) conduct stakeholder and local community consultations and participatory planning exercises to be incorporated into the design of the subprojects.

North-West Power Generation Company Limited (NWPGCL), an enterprise of Bangladesh Power Development Board, aims to develop a power plant at Khulna, in the south-western part of Bangladesh. The power plant will be of a nominal capacity of 800 megawatts (MW), and will use combined cycle gas turbine technology. It will be designed to operate on natural gas as the primary fuel, and with high speed diesel as the secondary fuel. As the current gas throughput in the national gas grid is not sufficient to supply the daily natural gas required to operate the proposed power plant, NWPGCL will not source natural gas from production facilities in Bangladesh, but will be importing regasified liquefied natural gas (LNG) from India through a cross-border pipeline. The in-feed to the cross-border pipeline on the India-side, would be regasified LNG sourced from the Floating Storage Regasification Unit to be located offshore in Digha, West Bengal. The TA will support the ongoing due diligence and preparatory work for the ensuing project. Its impact will be improved readiness in implementing clean energy projects. The outcome will be a well-designed investment project developed.

The project will develop 460 hectares (ha) of riparian land near the city of Phuentsholing that is located adjacent to the Amochhu River on Bhutans southwestern border with India. It will provide protection from floods and erosion, and construct smart urban infrastructure to allow phased urban expansion. A modern township will be designed on modern sustainable principles of equity, livability, and competitiveness, and will be integrated into the fabric of the existing municipality preserving Bhutan's unique architectural heritage. The project will also protect new and oldtowns from floods and riverbank erosion which currently threatens lives and livelihoods, and disrupts connectivity with nearby communities. The TA will: (i) review the project's technical, economic and financial viability; (ii) review and update safeguard measures; (iii) review civil works contract documents to ensure adherence to ADB's criteria; (iv) prepare the consulting package for the project implementation consultant and support the recruitment process; (v) undertake financial and procurement capacity assessments of the implementing agency; (vi) prepare all requirements to meet the processing criteria for a loan project; and (vii) support loan start-up activities.

The additional financing (AF) will enhance agricultural productivity and improve access to markets in 270 target communes through investments in climate-resilient productive infrastructure, capacity building in disaster risk management of the communities and commune councils, and creation of an enabling environment for agricultural productivity, diversification and climate resilience. It will also strengthen ADB's basin-scale strategic approach in the Tonle Sap basin by creating synergies with other projects, such as the Climate-Resilient Rice Commercialization Sector Development Program. The TA will carry out due diligence and produce full documentation of the AF. It will determine the geographical scope of the AF, guide the selection and design of infrastructure subprojects including criteria for climate resilience and disaster risk reduction, complete feasibility studies of two representative subprojects; update financial management assessment of the executing agencies, conduct financial sustainability assessment and economic analysis; and recommend best practices for climate-resilient agriculture and disaster risk management.

The project will establish and operate facilities to capture and sequester carbon dioxide (CO₂) from a natural gas processing plant in Gundih, Central Java, Republic of Indonesia. It will also develop carbon capture and storage (CCS) regulation for deploying CCS technology in Indonesia. During the 2-year pilot, the project will capture and store 20,000 tons of CO2 and increase awareness of and experience with CCS technology in the country. The pilot is essential to increase domestic awareness of CCS, test CCS technology in the Indonesian context, and to demonstrate CCS storage and monitoring performance. The project will strengthen institutional capacity for reducing greenhouse gas emissions in Indonesia which is aligned with Indonesia's Intended Nationally Determined Contribution to the United Nations Framework Convention on Climate Change. Its outcome will be the successful transfer of CCS technology. Project outputs will include: (i) CCS facilities at Gundih and Jepon-1; and (ii) published CCS regulatory framework. The TA is required to finalize due diligence on technical and safeguard aspects of the project and to provide procurement-related support to the executing agency. Its outputs are a fully prepared grant and a successfully completed bidding process for the carbon capture and storage plant. This will include final technical assessments of the proposed carbon capture and storage plant, completed safeguards due diligence, industry outreach on the planned project, invitation for bidding, bid evaluation reports, and successful contract negotiations.

The existing road maintenance management system in Kazakhstan does not provide for systematic process of measurement of the conditions of the road infrastructure, its diagnosis and forecasting future expenditures associated with its maintenance on the long-term basis. The executing agency (EA) has no previous experience in the preparation and implementation of performance-based road maintenance contracts. The project will improve the road maintenance system in the country through changes in the institutions and the allocation of funds. It aims to introduce performance-based maintenance of roads, which will ensure the sustainability of road infrastructure by improving the efficiency of the maintenance activities. This will result to better connectivity and local employment growth. The project will provide a sustainable efficient movement of people and goods to domestic and international markets. The outcome is improved performance of the republican road network in Kazakhstan. The TA will prepare the project and assist the EA with the bidding process up to the award of the contract.

TA 9169-KGZ: Second Issyk-kul Sustainable Development

The project will improve public health and environmental conditions within the area of the Issyk-Kul Lake by expanding and improving wastewater systems in selected urban centers around its shoreline. The government has sought ADB assistance to improve environmental management and urban services in the region through the Issyk-Kul Sustainable Development Project (ISDP), which is being implemented in the lakeshore towns of Cholpon-Ata, Balykchy and Karakol. Building on the ISDP that developed sewage collection systems, the project will complete the sewerage systems in these towns by developing a collection system in Cholpon-Ata and wastewater treatment systems in all three towns. It will also improve environmental monitoring procedures, and further strengthen the institutional capacity of implementing and regulatory institutions. The project will improve health, hygiene and sanitation conditions of the residents in the selected towns of the Issyk-Kul region. The outcome is improved wastewater services in the selected towns of Issyk-Kul oblast. The TA will assist the government to conduct feasibility study, due diligence, and safeguard assessment for the proposed ISDP II project, particularly to ensure that the bank's safeguard standard should be strictly implemented in the Issyk-Kul area. Moreover, to ensure long term financial and environmental sustainability, initial cost recovery actions and tourism development activities will be identified.

The future loan project will construct three new 230 kilovolt (kV) transmission lines (approximately 480 km) with five 230 kV substations, 60 medium voltage substations, and 900 km distribution lines in five regions in Myanmar. It will install computerized systems to improve operational efficiency and reduce losses in the transmission and distribution systems. It will also contribute to increasing electricity supply to support inclusive and sustainable development, and in achieving the country's plan of universal electricity access by 2030. The outputs of the project will be: (i) additional three new 230 kV transmission lines and five new substations with capacity of 700 megavolt-amperes; (ii) new distribution facilities added to the distribution systems in Ayeyarwady, Bago, Mon, Kayin, and Rakhine regions; and (iii) a new computerized asset management system and computerized customer billing system. The TA will: (i) confirm the rationale and priority of the transmission and distribution components respectively: (ii) prepare technical design and cost estimates for subprojects and propose appropriate contract packaging and procurement plans; (iii) conduct economic and financial due diligence; (iv) undertake social impact assessment, capacity, and governance assessment; (v) carry out social, resettlement, and environment safeguard due diligence and stakeholders consultation in accordance with 2009 ADB Safeguard Policy; and (vi) prepare engineering design and bidding documents, and assist in preparing request for proposal for project implementation consultants.

It was estimated that 20 million people in Myanmar live in villages without access to an all-season road, which is over half of Myanmar's rural population. The project will improve about 350 km of rural roads in two pilot regions, Ayeyarwaddy and Sagaing, and develop the technical bases and capacity for the nationwide rural roads and access program, part of which will be financed by ADB. Its outcome is improved accessibility of rural people. The TA) will: (i) help select target roads; (ii) prepare basic engineering designs; (iii) conduct ADB's due diligence in financial, social and environmental areas; (iv) prepare required due diligence documents; and (iv) support early procurement. It will cover engineering, economic, financial, social and environmental aspects, as well as procurement preparation and support. Engineering will be carried out in sufficient detail to carry out the procurement of the works.

The project will be ADB's first investment in Nepal that will specifically target energy efficiency through distribution system enhancement to meet the immediate needs of electricity distribution network in Kathmandu Valley and strengthening of associated transmission lines by the Nepal Electricity Authority (NEA). Major sections of the existing distribution network in the valley were constructed decades ago and despite significant increase in electricity demand and the number of consumers, minimal reinforcement of the distribution network has been carried out. The project will enhance the distribution capacity and improve reliability and quality of electric supply in the Kathmandu Valley by reducing distribution system overloads and technical and commercial losses, which currently is about 20%. It will also support the implementation of other system efficiency upgrades and energy efficiency measures such as advanced grid operations software, distribution system automation, and smart metering. System efficiency improvements and loss reductions will improve NEA's financial health, while customers will benefit from a reliable and improved quality of electricity supply and reduced dependence on diesel generators to meet their daily electricity needs. Operational upgrades will also facilitate integration of new generation capacity scheduled to come on-line during the next three to four years. The TA will conduct project due diligence covering technical, economic, financial, procurement, and social and environmental safeguards, as well as preparing medium to long term planning for the electricity distribution enhancement in Kathmandu Valley. It will include some capacity development support essential to prepare for and expedite implementation.

It will improve the access and quality of water supply services by: (i) financing the remaining investment gaps for Melamchi water source development; (ii) rehabilitating and expanding the water supply distribution system; and (iii) further strengthening the Kathmandu Valley's water supply and sanitation institutions. The loan will finance: (i) priority water source development works, including supply of additional 340 million liters per day of treated water; (ii) critical rehabilitation works; and (iii) distribution network improvements to address the remaining supply gap and provide 24-hour drinking water supply to 70% of the households in the Kathmandu Upatyaka Khanepani Limited service area. It will also support the planning for sustainable development of smaller and more localized sources to supplement the larger scheme and meet the remaining supply gap. The TA will: (i) review technical, economic, institutional, and financial viability; (ii) review and update safeguard measures; (iii) review civil works contract documents and prepare consulting packages under the loan; (iv) prepare all requirements to meet the processing criteria for a loan project; and (v) support loan start-up activities.

The multitranche financing facility (MFF) will improve the railway sector in Pakistan by making the railway transport system more efficient and competitive. The outcome will be improved railway corridor of Lahore-Peshawar and improved Pakistan Railways (PR)' institutional efficiency. The Lahore-Peshawar railway line connects major cities in Punjab, Pakistan's wealthiest and most populous province. Peshawar is a key point in transit trade with Afghanistan and beyond to Central Asia. The entire line is part of the Central Asia Regional Economic Cooperation Corridor 6c. The project outputs include: (i) approximately 411 km of upgraded and dualized railway track for the Lahore-Peshawar section of ML-1 together with new signaling and telecommunications system (including power supply for these systems) and upgraded passenger facilities at Lahore, Rawalpindi, and Peshawar stations; (ii) 52 km of newly constructed double-track rail line linking Kaluwal and Pindora; and (iii) PR's modernized accounting system with the accounting data and information migrated into the new accounting system. The TA will: (i) develop an MFF and tranche projects suitable for ADB financing; (ii) conduct due diligence for technical, economic, financial, social, and environmental viability of the 1st tranche project and prepare required due diligence documents. It will also conduct a feasibility assessment for the 1st tranche project including preliminary engineering designs; cost estimates; technical, financial, economic, and socioeconomic analysis; environmental analysis; social impact assessment; a study for initial benchmark performance indicators; and preparation of project evaluation and monitoring framework.

The investment program aims to: (i) improve energy security by increasing the clean energy share in the energy mix currently dominated by thermal energy; (ii) promote private sector investments in hydropower development in the province of Khyber Phakhtunkhwa (KPK) which has the most hydro potential in the country; and (iii) build capacity and understanding on climate change impacts, adaptation and mitigation measures. It is structured to facilitate investments in the development of hydropower plants by utilizing both public and private sector investments and leveraging ADB funds through syndication and other financial structures. ADB catalytic financing in the long-term will support and create a business-friendly environment making hydropower plant (HPP) projects bankable for the private sector to mobilize and invest through debt or equity. Likewise, evaluations on possible areas of expansion like support to micro-, small- and medium-sized enterprises and engagement with state-owned enterprises will provide insights on new business opportunities for ADB. Further, with the enhanced financial capacity, a review of the financing modalities, like policy-based lending, needs to be undertaken. The selection and design of evaluations should also take into account recent global developments like the Sustainable Development Goals and the 2015 Paris Climate Conference. Evaluations should consider how ADB will engage with middle income countries (MIC) as most of its DMCs will be MICs in the near future. High-level thematic and sector evaluation work will need to build on evaluations of country and project performance.
