Subject: **Grant No. 0524-BAN(EF): Coastal Towns Environmental Infrastructure Project – Additional Financing –Amendment to the Grant Agreement**

1. We refer to the Grant Agreement (“Grant Agreement”) dated 11 February 2018 with Grant No. 0524-BAN(EF) between People’s Republic of Bangladesh (“Recipient”) and Asian Development Bank (“ADB”) for the Coastal Towns Environmental Infrastructure Project – Additional Financing (“Project”). All capitalized terms used but not defined herein have the meanings given thereto in the Grant Agreement, unless the context requires otherwise.
2. We note that there is an error in the total amount indicated in the Table found in the Attachment to Schedule 2 of the Grant Agreement. To rectify this error, ADB proposes that the Grant Agreement be amended as set out in the attachment hereto.
3. Save and except to the extent set out in the attachment hereto, the Grant Agreement remains unchanged.


