一、审计师意见

审计师意见

吉安市城市建设投资开发公司：

我们审计了亚洲开发银行贷款江西省吉安城市交通项目 2018 年 12 月 31 日的资金平衡表及截至该日同年度的项目进度表、贷款协定执行情况表和专用账户报表等特定目的财务报表及财务报表附注（第 5 页至第 16 页）。

（一）项目执行单位及江西省财政厅对财务报表的责任

编制上述财务报表中的资金平衡表、项目进度表、贷款协定执行情况表及财务报表附注是你公司的责任，编制专用账户报表是江西省财政厅的责任，这种责任包括：

1. 按照中国的会计准则、会计制度和本项目贷款协定的要求编制项目财务报表，并使其实现公允反映；
2. 设计、执行和维护必要的内部控制，以使项目财务报表不存在由于舞弊或错误而导致的重大错报。

（二）审计责任

Auditor's Opinion

We have audited the special purpose financial statements (from Page 5 to Page 16) of Jiangxi Ji'an Sustainable Urban Transport Project Financed by the Asian Development Bank, which comprise the Balance Sheet as of December 31, 2018, the Summary of Sources and Uses of Funds by Project Component, the Statement of Implementation of Loan Agreement and the Special Account Statement for the year then ended, and Notes to the Financial Statements.

Project Entity and Jiangxi Provincial Finance Department's Responsibility for the Financial Statements

The preparation of the Balance Sheet, the Summary of Sources and Uses of Funds by Project Component, the Statement of Implementation of Loan Agreement and Notes to the Financial Statements is the responsibility of your entity, while the preparation of the Special Account Statement is the responsibility of Jiangxi Provincial Finance Department, which includes:

1. 项目概况

亚洲开发银行贷款、GEF 赠款江西省吉安城市交通项目贷款号为 3216—PRC，旨在通过该项目的实施，使项目区加快改善城市基础设施建设。该项目涉及吉安市城市建设投资开发公司项目实施机构，主要项目活动包括（1）公共交通改善—包括建设一条 6.9 公里的快速公交（BRT）系统；（2）玉带河河流和河道治理；（3）交通管理和城市交通改善；（4）机构能力建设。项目贷款协议于 2015 年 4 月 22 日签订，2015 年 9 月 8 日生效，预计 2020 年 6 月 30 日前关闭。项目计划总投资为折合人民币 17.7 亿元，其中亚洲开发银行贷款 1.2 亿美元。

2. 财务报表编制范围

本财务报表的编制范围为吉安城市交通项目利用亚行贷款工作领导小组管理办公室对吉安城市交通项目资金筹集和建设投入的会计核算。

3. 主要会计政策

3.1 本项目财务报表按照财政部《世界银行贷款项目会计核算办法》（财际字〔2000〕13 号）的要求编制。

3.2 会计核算年度采用公历年制，即公历 1 月 1 日至 12 月 31 日。

3.3 本项目会计核算以“权责发生制”作为记账原则，采用借贷复式记账法记账，以人民币为记账本位币。

3.4 按照中国人民银行 2018 年 12 月 28 日汇率，即 USD1=人民币 6.8632 元。

4. 报表科目说明



4.1 项目支出

2018 年项目支出人民币 132,291,189.30 元，累计支出人民币 511,403,077.95 元。

4.2 货币资金

2018 年 12 月 31 日货币资金余额为人民币 114,175,301.08 元，其中财政厅亚行专用账户余额为 1,388,669.29 美元(按 2018 年 12 月 28 日汇率计人民币 9,530,715.07 元)。

4.3 预付及应收款

2018 年 12 月 31 日余额为人民币 520,037,726.34 元，主要是付君华大道、阳明西路工程土建施工、BRT 快速公交咨询服务费、耕地开垦费以及管线迁改的费用。

4.4 项目拨款

2018 年 12 月 31 日余额为人民币 409,750,000.00 元，为项目配套资金。

4.5 项目借款

2018 年 12 月 31 日余额为人民币 507,256,658.07 元，为银行贷款，其中亚行贷款余额为人民币 107,256,658.07 元，国内银行贷款余额人民币为 400,000,000.00 元。

4.6 其他应付款

2018 年 12 月 31 日余额为人民币 219,123,228.69 元，主要是吉安市城市建设投资开发公司代付项目前期费、代归还华夏银行贷款以及吉安市高铁站前新区项目推进指挥部代付阳明西路工程房屋拆迁征地款等。

5. 专用账户情况

本项目贷款专用账户设在江西银行南昌迎宾大道支行，账号为 791909542720015，币种为美元。2017 年专用账户首次存款 3,000,000.00 美元。2018 年年初余额为 1,864,108.53 美元，本年度回补 10,330,587.93



美元，利息收入为 982.11 美元，本年度支付 10,807,009.27 美元，年末余额 1,388,669.29 美元。

v. Notes to the Financial Statements

Notes to the Financial Statements

1. Project Overview

The Loan No. of Jiangxi Ji'an Sustainable Urban Transport Project financed by the Asian Development Bank and granted by GEF is 3216-PRC. The project aims to accelerate and improve the construction of urban infrastructure. The project is carried out by Ji'an Urban Construction & Investment Development Company. Its major activities include (1) public transport improvement—including the construction of a 6.9km BRT corridor; (2) the Yudai River rehabilitation; (3) traffic management and urban roads development; (4) institutional capacity development. The Project Loan Agreement was signed on April 22, 2015 and came into effect on September 8, 2015. The account of the project is expected to be closed before June 30, 2020. The total planned investment of the project was equivalent to RMB 1.77 billion yuan, among which the ADB loan is USD 120 million.

2. Consolidation Scope of the Financial Statements

The consolidation scope includes the accounting of the fund raising and construction investment of Ji'an Urban Transport Project conducted by Ji'an ADB Loan Management Office

3. Major Accounting Policies

3.1 The Financial Statements of the project were prepared according to the requirements of *Accounting Methods for the World Bank Financed Project* (Caijizi [2000] No.13).

3.2 In accounting practice, the Gregorian calendar year is adopted as the fiscal year from January 1 to December 31.

3.3 The accrual basis and the debit/credit double entry bookkeeping method are adopted. RMB is used as the recording currency of bookkeeping.

3.4. The exchange rate adopted in the financial statements was the exchange rate on December 28, 2018 of the People's Bank of China, which is USD 1=RMB 6.8632 yuan.



4. Explanation of Subjects

4.1 Total Project Expenditures

The project expenditure in 2018 was RMB 132,291,189.30 yuan, and the cumulative expenditures were RMB 511,403,077.95 yuan.

4.2 Total Cash and Bank

As of December 31, 2018, the balance was RMB 114,175,301.08 yuan, including the balance of Special Account USD 1,388,669.29 (equivalent to RMB 9,530,715.07 yuan based on the exchange rate on December 28, 2018).

4.3 Total Prepaid and Receivable

Its balance on December 31, 2018 was RMB 520,037,726.34 yuan, mainly used to pay the fees for consulting, land reclaiming and pipe migration of the civil construction of Junhua Avenue, West Yangming Road and BRT projects.

4.4 Total Project Appropriation Funds

Its balance on December 31, 2018 was RMB 409,750,000 yuan, mainly the paid-in counterpart funds.

4.5 Total Project Loan

Its balance on December 31, 2018 was RMB 507,256,658.07 yuan from bank loan, including balance of ADB loan RMB 107,256,658.07 yuan and of domestic bank loan RMB 400 million yuan.

4.6 Total Payable

Its balance on December 31, 2018 was RMB 219,123,228.69 yuan, mainly the upfront fees of the project and the Huaxia Bank loan paid by Ji'an Urban Construction & Investment Development Company, and the fees of house/land acquisition and resettlement for West Yangming Road construction paid by Ji'an Project Promotion Headquarters in the Highspeed Rail Zhanqian New District.

5. Special Account

The Special Account for ADB loan was opened in Yingbing Avenue Branch, Jiangxi Bank, with the account No. being 791909542720015 and the currency being USD. The initial deposit of the Special Account was USD 3 million in



2017. The beginning balance of 2018 was USD 1,864,108.53 and the replenishment in the year was USD 10,330,587.93. This year the interest earned was USD 982.11 and the disbursement USD 10,807,009.27. The balance on December 31, 2018 was USD 1,388,669.29.

6. Other Matters

In the BALANCE SHEET of 2017, "Ending Balance" listed in "Cash in Bank" was RMB 170,026,938.86 yuan, which was a wrong figure since it did not include the balance in Special Account. The correct figure is RMB 182,207,396.72 yuan, which has been corrected in "Beginning Balance" of the BALANCE SHEET of 2018, with "Total Cash and Bank" unaffected.
