Subject: Loan 3169-BAN(Ordinary Operations): South Asia Subregional Economic Cooperation Railway Connectivity: Akhaura-Laksam Double Track Project — Amendment to the Loan Agreement (Ordinary Operations)

- 1. This refers to the Loan Agreement (Ordinary Operations) between The People's Republic of Bangladesh (the Borrower) and the Asian Development Bank (ADB), for the South Asia Subregional Economic Cooperation Railway Connectivity: Akhaura-Laksam Double Track Project (Project), duly signed on 28 June 2015 (hereinafter referred to as the Loan Agreement (Ordinary Operations)).
- 2. The Borrower has requested ADB to include new categories for safety equipment and consulting services under the Loan Agreement (Ordinary Operations) to finance contracts for safety equipment and consulting services that were awarded under loans MFF 0004 BAN: Railway Sector Investment Program.
- 3. Upon the request of the Borrower, the Loan Agreement (Ordinary Operations) is hereby amended as follows:

Amendment to Schedule 2:

Paragraphs 3 is hereby amended in its entirety to read as follows"

- "3. The amount allocated to Category 4 is for financing interest and commitment charges on the Loan during the implementation period of the Project. ADB shall be entitled to withdraw from the Loan Account and pay to itself, on behalf of the Borrower, the amounts required to meet payments, when due, of such interest and commitment charges.
