I. THE TECHNICAL ASSISTANCE SUBPROJECT

A. Overall Progress of the Technical Assistance cluster

- 1. The Sustainable Development and Climate Change Department (SDCC) supports operations departments to operationalize corporate directions of Asian Development Bank (ADB) through meaningful engagement with civil society to improve development effectiveness through the knowledge and support technical assistance (TA) cluster on Deepening Civil Society Engagement for Development Effectiveness, approved on 27 November 2017. The TA cluster will contribute to the improved delivery of inclusive development services in selected developing member countries (DMCs), in support of the Sustainable Development Goals, by contributing to stronger civil society organization (CSO) participation in ADB operations. The three outputs of the TA cluster are: (i) capacity for effective CSO engagement in the design, implementation, and monitoring of ADB projects improved; (ii) demonstration activities through effective CSO engagement conducted; and (iii) knowledge products about effective CSO engagement in ADB operations generated and shared. The TA cluster target completion date is 31 December 2020. The TA cluster links directly to ADB's focus on civil society engagement as articulated in Strategy 2030.¹
- 2. The TA cluster progress is on track.² Two of the three planned subprojects have been approved. Subproject 3 is the third subproject planned under the TA cluster. Subproject 1 focused on selected countries in three ADB regional departments: Central and West Asia Department, East Asia Department, and Pacific Department.³ Subproject 1 became effective on 20 December 2017. Progress is on track. Under output 1, delivery of the capacity building products and services for CSOs and government agencies on effective CSO engagement in ADB projects is complete. Under output 2, progress towards dissemination of good practice on the contribution of CSO participation to improving the quality of ADB operations is substantial; four knowledge products are complete and available online.⁴ Towards output 3, all five project CSO-participation plans are nearly complete or nearing completion, and the country reports are being finalized. Work on all activities under output 4, CSO knowledge and perspectives in ADB operations generated, is complete or nearing completion.
- 3. Subproject 2 became effective on 19 September 2018 and supports activities in selected South and Southeast Asian DMCs.⁵ About half of Subproject 2 resources are allocated to support civil society participation in the graduation approach⁶ in the Philippines, and the other half supports civil society engagement in planned and ongoing projects in selected South and Southeast Asian DMCs and the preparation of knowledge products documenting civil society engagement. Progress is on track for both outputs.

The graduation approach is a comprehensive, holistic, time-bound, and carefully sequenced set of interventions that aims to "graduate" people from extreme poverty to more sustainable livelihoods.

B. Subproject Outcome

4. The subproject will have the following outcome: CSO participation in ADB operations strengthened. Subproject 3 will support all three outputs of the TA cluster.

C. Subproject Outputs, Methods, and Activities

- 5. The Subproject 3 will further deepen the TA cluster activities in selected DMCs in all operations departments. It will include (i) expanded implementation of in-country capacity building and enhanced CSO engagement programs across selected DMCs (output 1); (ii) additional participatory CSO initiatives in new and ongoing projects in selected DMCs (output 2); and (iii) expanded knowledge generation and sharing activities, drawing on outputs and outcomes of Subproject 1 and Subproject 2, and completion of activities showcasing lessons in deepening ADB–CSO engagement (output 3); and (iv) project management.
- 6. Output 1: Capacity for effective civil society organization engagement in the design, implementation, and monitoring of Asian Development Bank projects improved. Aligned with output 1 of the TA cluster and building upon the support provided to Pacific island DMCs in Subproject 3 will support a capacity building workshop for CSO representatives and DMC officials from the Pacific. The 5-day workshop will cover a range of topics which build capacity for effective CSO engagement in the design, implementation, and monitoring of ADB-financed projects. In addition, the event aims to strengthen relations among participants, improving knowledge of each other's roles in the ADB project cycle. Participants will each complete the tailored e-learning training course developed under Subproject 1 prior to attending the workshop.
- output 2: Demonstration activities through effective civil society organization engagement conducted. Aligned with output 2 of the TA cluster, the TA will support a range of interventions by civil society to add value and strengthen the results of ADB-financed projects. First, the TA will support seven proposed ADB-financed projects through higher-level CSO engagement. Three of the projects will be in Uzbekistan, where the President's new decree on the development of CSOs and their active involvement in policy making⁷ has created opportunities for CSO engagement in the ADB portfolio.⁸ Details of the interventions appear in the terms of reference are available in the linked documents in Appendix 3. These demonstration projects are based upon exploratory work financed under Subproject 1, where ADB commissioned a report on opportunities for CSOs in Uzbekistan to collaborate on ADB-financed projects. The other two projects are in Armenia and Georgia, where civil society capacity and interest in collaborating on ADB-financed projects is growing. In Georgia, the innovative learning methodology for kindergartens demonstration project will bring a CSO-led kindergarten improvement initiative into the scope of the Livable Cities Development Investment Program, highlighting how CSOs are actively improving the livability of cities across Georgia through innovative educational initiatives.
- 8. In South Asia, the project will support two CSO engagement demonstration activities. The projects, ranging from design to evaluation stage, will receive support for civil society-led complementary activities. These projects will be identified during the implementation of

The three projects this TA will support are: (i) <u>Second Tashkent Province Water Supply System Development Project</u> (community awareness raising campaign on water use and water hygiene), (ii) <u>Livestock Value Chain Development Project</u> (farmer awareness raising and capacity building in areas where farmers are poorest), and (iii) CAREC Corridor 2 Karakalpakstan Road Project (empowering women in line with the Gender Action Plan priorities).

Subproject 3. Examples of activities include financing CSO consultations during processing to help improve project design, such as with road safety groups for road projects or parent teacher associations for education projects. A women's organization may be engaged to assist with the implementation of additional activities to a project's gender action plan, which result in stronger project results. The project will also support outreach, communications materials, and/or related activities to engage with advocacy and operational CSOs involved in ADB-financed projects in South Asian countries. SDCC will seek governments' concurrence—as needed—prior to the implementation of each identified activity.

- 9. The TA may support other small interventions of CSO engagement in projects at the design or implementation phase on an on-demand basis. Selection will be determined in close coordination with the regional departments, based on the following criteria: (i) CSO participation will add value to the project; (ii) CSO expertise is available that meets the project's needs; and (iii) the implementing agency is interested to see how CSO participation will strengthen project results.
- 10. In order to formalize the role of civil society in ADB's portfolio in Armenia and Uzbekistan, countries where recent political changes have created new opportunities for CSO engagement, the TA will support development of CSO country operations assessments and ADB-CSO country cooperation action plans. These documents will outline the opportunities for engaging with civil society and detail specific actions for strengthening CSO engagement in each. To complement the action plans, the TA will also support preparation of country reports on policies and programs for CSO engagement in national development plans. These reports, which Subproject 1 supported for Georgia and Mongolia, help inform project design of government's national development plans which involve civil society and identify opportunities for collaboration. In Georgia and Mongolia, the sustainable development goals and the Open Government Partnership provided channels for CSO engagement into national development plans. The TA will explore what systems exist in Armenia and Uzbekistan.
- Output 3: Knowledge products about effective civil society organization 11. engagement in Asian Development Bank operations generated and shared. Output 3 of Subproject 3 mirrors output 3 of the TA cluster. The TA will support the dissemination of learning about the graduation approach, a model of successful CSO engagement, which Subproject 2 financed. The graduation knowledge event and immersion visit will showcase ADB's existing investment in the graduation approach with support from civil society partners BRAC and Innovations for Poverty Action. 10 This initiative is the first government-led execution of the graduation approach in the Philippines, and, as such, serves as not only a base for further expansion and scale nationally by government entities in the Philippines, but further constitutes an exceptionally strong demonstration effect for peer governments in the region. The event, consisting of a 2-day field immersion visit and 1-day event in Manila, will bring together ministry officials from neighboring countries keen to better understand social protection and economic inclusion approaches akin to graduation. These officials will have the opportunity to conduct an in-depth immersion visit to the Department of Labor and Employment-implemented project, coupled with a learning event to showcase implementation lessons learned, a robust research agenda assessing impact and cost implications of the approach, as well as institutional arrangements which facilitated the launch of the project. It will further serve as a platform for regional dialogue across country governments.

12. The TA will support the publication of two CSO briefs published in the ADB series. The CSO Briefs series, published by the NGO and Civil Society Center (NGOC), provides an overview of the civil society landscape in 27 DMCs and are a useful tool for DMC officials to identify opportunities for CSO engagement. ¹¹ The knowledge products prepared under this TA subproject will be widely shared through ADB's social media channels, incorporated into staff training that NGOC delivers annually, included in e-learning modules for DMC officials and CSOs where possible, shared through the civil society program of the annual meeting as appropriate, disseminated through resident missions, and posted on the ADB website. Electronic versions will be the default; knowledge products will only be printed when needed to reach the target audience.

D. Subproject Cost and Financing

13. The TA subproject is estimated to cost \$500,000, which will be financed on a grant basis by ADB's Technical Assistance Special Fund (TASF-6). The key expenditure items are listed in Appendix 2. The government will provide counterpart support on a case by case basis as appropriate for each demonstration activity under Output 2. The support may include counterpart staff, office and housing accommodation, office supplies, secretarial assistance, and domestic transportation, and will be determined when the TA subproject support is planned for the demonstration activity.

E. Subproject Implementation Arrangements

- 14. ADB will administer the TA. Subproject 3 will be managed by the NGOC within the Thematic Advisory Service Cluster (SDTC) in close coordination with dedicated staff from ADB headquarters and resident missions of selected operations departments allocated to support implementation or act as resources persons, and who will also participate in TA activities. SDCC will select, supervise, and evaluate consultants, in consultation with relevant operations departments, as needed. Disbursements under Subproject 3 will be in accordance with ADB's Technical Assistance Disbursement Handbook (2010, as amended from time to time).
- 15. The implementation arrangements are summarized in the table.

- 16. **Consulting services**. ADB will engage all CSOs and an individual consultant following the ADB Procurement Policy (2017, as amended from time to time) and its associated project administration instructions and/or staff instructions. Under output 2, ADB will engage seven national CSOs to conduct CSO demonstration activities in selected DMCs. These organizations will be engaged using a simplified technical proposal and consultants' qualifications selection or single source selection (Table 1) using a performance-based contract with payments made upon acceptance of deliverables. All contracts proposed for single source selection are valued at \$50,000 or less and ADB has completed due diligence on all them. Terms of reference for consultants and firms to be engaged are available in the list of linked documents in Appendix 3. The terms of reference for CSO participation in the project in Armenia and the two projects in South Asia will be prepared upon finalization of the needs identification and project selection.
- 17. ADB will engage the Georgian CSO Library-Cultural Center Tanadgoma for the innovative learning methodology for kindergartens demonstration project using single source selection. The project will apply neuroplasticity-based learning in kindergarten learning. Among the very few CSOs working in its field, Tanadgoma is the only organization that has adopted neuroplasticity-based learning methodology in the country, which is the intellectual property of the CSO's Program Director. ADB will engage the Business Women's Association in Uzbekistan using single source selection to implement the gender awareness demonstration project. As the only women's CSO operating in Karakalpakstan, an extremely remote area of Uzbekistan, and having a solid track record since 2003 with previous collaboration with ADB, BWA is best positioned to implement this contract. Lastly, ADB will engage Khorezm Rural Advisory Support Service (KRASS) in Uzbekistan using single source selection to design and lead a farmer's awareness campaign to improve the impact of the livestock value chain project. KRASS is known to ADB, has a national presence, and is a leader in farmer training in Uzbekistan.
- 18. One individual national consultant will be engaged to support CSO engagement in Armenia, Georgia, and Uzbekistan. The expert will prepare strategic CSO engagement documents, support the implementation of CSO engagement strategies, and provide technical support to the demonstration projects in these countries.
- 19. The TA subproject will require 11.5 person-months of an individual national consultant. The number of person-months required for national firms cannot be calculated since several will use consultants' qualifications selection or output based terms of reference. The project will also engage resource persons from time to time to support the project's objectives.
- 20. **Non-consulting services**. In output 3, ADB will engage BRAC using service contract to organize the graduation approach workshop. SDCC will use direct contracting because BRAC is implementing the graduation approach under the Technical Assistance for Unlocking Innovation for Development¹² and subproject 2, and both efficient resource use and knowledge of project results require the same CSO undertakes the workshop organization. ADB performed due diligence on BRAC and they are meeting ADB requirements under their contract in Subproject 2.
