**Subject: Grant No. 0645-CAM (EF): National Solar Park Project
– Amendment to Grant Agreement**

1. We refer to the Grant Agreement dated 28 June 2019 between Kingdom of Cambodia ("Recipient") and Asian Development Bank ("ADB"), acting solely in its capacity as an implementing entity of the Strategic Climate Fund ("SCF"), for the captioned project ("Grant Agreement"). All capitalized terms used but not defined herein shall have the meaning given thereto in the Grant Agreement, unless the context requires otherwise.
2. Following a request from the Recipient dated 11 November 2021, ADB approved, on 8 December 2021, among other things, changes in the Project concerning the creation of a new category of grant proceeds. To give effect to the change, ADB proposes that the Grant Agreement be amended as set out in the attachment hereto.
3. Save and except to the extent set out in the attachment hereto, the Grant Agreement remains unchanged.
4. Pursuant to ADB's Access to Information Policy (2018) ("AIP"), the amendment to the Grant Agreement will be posted on ADB's website within 2 weeks from the date that the amendment becomes effective, after removing any information that falls within the AIP exceptions as specified by the Recipient.
5. Please indicate the Recipient's concurrence to the amendment set out in the attachment hereto and to the terms of this letter agreement by countersigning each of the two original of this letter agreement in the space indicated below. Please retain one signed original of this letter agreement for your records and return the other to ADB. The proposed amendment shall take effect on the date of receipt by ADB of a signed original of this letter agreement.
