#### I. THE ENSUING PROJECT

- 1. The Chittagong Hill Tracts (CHT) is one of the poorest regions of Bangladesh. Poverty in the CHT stems from prolonged under-development in the five forms of capital which are necessary to sustain livelihoods and improve overall human well-being namely: (i) physical capital (i.e., the lack of roads and bridges, telecommunications, water supply, irrigation and agriculture facilities; (ii) human capital (i.e., the lack of access to education and vocational skills and health services; (iii) social capital (i.e., prevailing political tensions, fragmented local leadership, lack of governance and social exclusion; (iv) natural capital (i.e., unsustainable land uses as a result of uncertain tenurial rights, and increased climate vulnerability; and (v) financial capital (i.e., lack of personal savings and credit, limited inward remittances, and the limited flow of development funds from both the public and private sectors).
- 2. The proposed Climate Resilient Livelihood Improvement and Watershed Management in Chittagong Hill Tracts Sector Project will enhance sustainable livelihood opportunities and access to basic services for the rural population of the CHT. The project will be aligned with the following impact: enhanced human health and well-being, reduced vulnerability, and improved food security of the CHT people.¹ The project will adopt a holistic approach and address selected deficiencies in all five forms of capital that are lacking in the CHT. The project outputs will be: (i) rural roads rehabilitated; (ii) community infrastructure developed; (iii) watershed management strengthened; (iv) agriculture production, processing and marketing improved; and (v) rural non-farm skills related to agriculture value chains improved. A project of \$125 million for the Third Chittagong Hill Tracts Rural Development Project is included as a firm project in the 2021 lending pipeline of the Asian Development Bank's (ADB's) country operations business plan for Bangladesh, 2020–2022, and a transaction technical assistance (TRTA) of \$0.5 million to prepare it is included in the 2020 non-lending pipeline.²

#### II. THE TECHNICAL ASSISTANCE

#### A. Justification

3. The TRTA is required to support the government to prepare the ensuing sector loan.<sup>3</sup> The TRTA consultants will work closely with the assigned government counterpart staff to support preparation of: (i) feasibility studies, and bid documents (for the goods, works and services packages that must meet the readiness requirement); (ii) frameworks, procedures and templates for the remaining goods, works and services packages; (iii) required due diligence; and (iv) appropriate implementing arrangements. Adopting a fully consultative process, they will design outputs that meet the stated impact and outcome of the project. They will prepare all the project documents required to support processing and approval of the project by ADB. They will also provide start-up support to the government to mobilize implementation consultants and to take advance implementation actions.<sup>4</sup>

#### C. **Cost and Financing**

The TRTA is estimated to cost \$1,000,000 of which (i) \$500,000 will be financed on a 5. grant basis by ADB's Technical Assistance Special Fund (TASF-6) and (ii) \$500,000 will be financed on a grant basis by the Netherlands Trust Fund under the Water Financing Partnership Facility. The government will provide counterpart support in the form of counterpart staff, office accommodation and other in-kind contributions. The government was informed that approval of the TRTA does not commit ADB to finance any ensuing project. The key expenditure items are listed in Appendix 1.

#### D. **Implementation Arrangements**

6. ADB will administer the TRTA. ADB will select, supervise and evaluate consultants, and procure goods. The implementation arrangements are summarized in Table 2.
