We are pleased to inform you that on 7 June 2022, the Asian Development Bank (ADB) approved the provision of technical assistance (the Technical Assistance) to the Government of India (the Government) in an amount not exceeding the equivalent of USD1,000,000.00 for Support to Capacity Building Commission for Strengthening Institutional Capacities and Training Infrastructure.

The Technical Assistance will be financed and carried out pursuant to the (i) Technical Assistance Framework Agreement between the Government and ADB dated 10 July 1996; (ii) confirmed Aide Mémoire dated 1 April 2022 and confirmed by the Department of Economic Affairs on 27 May 2022; and (iii) arrangements described in paragraphs 13 to 14 of the Technical Assistance Report (TA Report) attached hereto as Annex 1. Please note that the TA will be implemented over a 3-year period.
