



## Invitation for Bids

1. The People's Republic of Bangladesh has received financing from the Asian Development Bank (ADB) toward the cost of **Emergency Assistance Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB.

2. The **Bangladesh Rural Electrification Board (BREB)** ("the Employer") invites sealed bids from eligible bidders for the "Design, Supply, Installation, Testing and Commissioning of 33/11KV, 10/14MVA Electrical Sub-station (Turn-key) in one package (herein after referred to as "the Plant") as detailed below:

3. **Open Competitive Bidding (OCB) – National** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all bidders from eligible countries as defined in Bidding Documents.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

a) Participation as a contractor or subcontractor or JV partner in one contract that has been successfully completed within the last 5 (five) years, counting backward from date of bid submission and that is similar to the proposed contract, where the value of the Bidder's participation exceeds BDT 60,000,000.00. The similarity of the Bidder's participation shall be based on:

- construction of 33/11 KV indoor sub-station or 33kv switching station or 132/33KV grid sub-station;

- Successful operation of installed 33/11 KV indoor sub-station or 33 KV switching station or 132/33 KV grid sub-station for at least one year.
5. A complete set of bidding document may be purchased by any interested eligible bidders upon submission of a written application to the above address and upon payment of a non-refundable fee of BDT 8000 only during regular office hours on all working days till 26 September 2018. The Mode of Payment will be Pay Order or Bank Draft in favor of Project Director, Emergency Assistance Project- BREB Component, Bangladesh Rural Electrification Board (BREB).
  7. A Pre-Bid meeting will be held at 11:00 Hours, Bangladesh Standard Time (BST) on 9 September 2018 at the Brig Gen. Sabihuddin Ahmed Hall (Auditorium), 1st Floor, Head office Building, BREB, Nikunja-2, Khilkhet, Dhaka-1229, Bangladesh.
  8. **Bids must be delivered to the address mentioned in paragraph 5 by 11:00 hours on 27 September 2018.** All bids must be accompanied by a bid security mentioned in the bid document in favor of the Project Director, Emergency Assistance Project- BREB Component, Bangladesh Rural Electrification Board (BREB) in the form of Bank Guarantee. Electronic bidding will not be permitted. Late Bids shall be rejected. Bids will be opened in the presence of the Bidders or his representatives who choose to attend at the same address above 11:30 hours on 27 September 2018.
