1. The People's Republic of Bangladesh has received financing from the Asian Development Bank (ADB) toward the cost of **Emergency Assistance Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB.

2. The **Department of Public Health Engineering (DPHE), Local Government Division (LGD), Ministry of Local Government, Rural Development and Cooperative (MLGRDC)**, ("the Employer") invites online bids from eligible bidders for the construction and completion for the work mentioned below:

3. **Open Competitive Bidding (OCB) – National** will be conducted in accordance with ADB's Procurement Regulations through electronic Government Procurement (e-GP) system and is open to all Bidders from eligible countries as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- **Contractual Experience:** Participation as a contractor, JV partner, or subcontractor, in at least 1 (one) contract that has been successfully or substantially completed within the last 5 (five) years and that is similar to the proposed works, where the value of the Bidder's participation exceeds BDT 115.00 Million (Bangladesh Taka One Hundred Fifteen million). The similarity of the Bidder's participation shall be based on: Physical Size, Nature of works, Complexity.
- **Average Annual Turnover:** Minimum average annual construction turnover of BDT 170.00 Million (Bangladesh Taka One Hundred Seventy Million) calculated as total certified payments received for contracts in progress or completed, within the last 3 (three) years.

- **Financial Resources:** The Bidder must demonstrate that its financial resources defined in Historical Financial Performance: Form W-2A of the bid documents, meet or exceed the total requirement for the Subject Contract of BDT 75.00 Million (Bangladesh Taka Seventy Five Million) (For joint venture lead partner needs to have 40%, each partner minimum 25% and jointly all partners should have the total requirement).

More details of eligibility and qualification requirements are mentioned in the bidding documents.

6. This is an online bidding where only e-Tender (e-bid) will be accepted in the Bangladesh National e-GP System Portal and **no offline/hard copies will be accepted**. Eligible interested bidders can participate in the bidding procedure upon payment of BDT 4,000 (Bangladesh Taka Four Thousand) in favor of "Executive Engineer, DPHE Cox's Bazar" toward the cost of bidding document as per the procedure described in the Bid Data Sheet. The tender security as mentioned in the documents have to be deposited online through any branch of the banks registered in the e-GP system.

8. **The deadline for submission of e-Tenders (bids) is 21 January 2019 at 15:00 hours Bangladesh Standard Time (BST) and online opening will be done on the same date and time.**
