1. The Government of the People's Republic of Bangladesh has received financing from the Asian Development Bank (ADB) towards the cost of **Dhaka Water Supply Network Improvement Project (DWSNIP)**, and part of the proceeds of this financing will be used for payments under the contract named above. Bidding is open to all Bidders from eligible source countries of the ADB.

2. The **Dhaka Water Supply and Sewerage Authority** (Dhaka WASA, "the Purchaser") invites sealed bids from eligible Bidders for the **Supply of HDPE Pipes & Fittings (Remaining supply of ICB-02.12)** ("the Goods"). A brief description of the type of goods and related services including completion period are as below:

3. **International Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: Two-Envelope](#) Bidding Procedure and is open to all Bidders from eligible source countries of ADB as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualification should participate in this Bidding:

- Successful completion as main supplier within the last five (5) years of at least one (1) contract valued at US\$ 2.7 million or two (2) contracts each valued at US\$ 1.35 million

with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).

- Minimum average annual turnover of US\$ 5 million calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years.
- The Bidder shall demonstrate that the goods offered have i) been in production for at least five (5) years, ii) been sold a minimum of 100 km of HDPE pipes and 1200 nos, of Fittings (considering minimum 75 mm dia) with similar type and specification over the last five (5) years; and iii) been in operation for a minimum of five (5) years.
- The Bidder or manufacturer shall demonstrate that it can supply the type, size, and quantity of the goods as required by Purchaser in accordance with the Delivery and Completion Schedule in Section 6 (Schedule of Supply).
- Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement which is US \$ 2.4 million.

The complete eligibility and qualification requirements are stipulated in the Bidding Documents.

The Bidding Document in the English language may be purchased directly or through authorized representative of interested Bidders upon submission of a written application to the address above and upon payment of a non-refundable fee BDT 5,000.00 or US\$ 60.00. The method of payment will be in Demand Draft/Pay Order in favor of the “Dhaka Water Supply Network Improvement Project (DWSNIP)”. The Bidding Document may be collected in person or may be sent by express airmail for an additional fee of BDT 300.00 for domestic delivery or US\$ 80.00 for overseas delivery. No liability will be accepted for loss or late delivery.

7. Bids must be delivered to the address above **on or before 19 September 2022, 14:00 hours (Bangladesh Standard Time)** accompanied by a Bid Security, as described in the Bidding Document. Bids will be opened at 15:15 hours on same day in the presence of Bidders’ representatives who choose to attend.

8. A Pre-Bid Meeting will be held at 11:30 hours (Bangladesh time) on 17 August 2022 at DWASA Conference Center, 3rd Floor, WASA Bhaban, Kawranbazar, Dhaka, Bangladesh.

9. The Purchaser will not be responsible for any cost or expense incurred by Bidders in connection with the preparation or delivery of bids.

10. When comparing Bids, ADB’s Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the Bidding Document.
