The Government of the People's Republic of Bangladesh has received financing from the Asian Development Bank (ADB) towards the cost of **Dhaka Water Supply Network Improvement Project (DWSNIP)**, and part of the proceeds of this financing will be used for payments under the contract named above. Bidding is open to all Bidders from eligible source countries of the ADB.

2. The **Dhaka Water Supply and Sewerage Authority** (Dhaka WASA, "the Employer") invites sealed bids from eligible Bidders for the **Rehabilitation of Distribution Network for NRW Reduction (DMAs 701A and 701B of ICB-02.12) with O&M Support, Contract No. NCB-02.12A (MODS Zone-7)** ("the Works"). A brief description of the type of works and related services including completion period are as below.

3. **National Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: Two-Envelope](#) Bidding Procedure and is open to all Bidders from eligible source countries of ADB as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualification should participate in this Bidding:

- Successful completion as main supplier within the last ten (10) years, of at least one (1) contract valued at US\$ 1,021,918.01 or BDT 96,000,000.00 or two (2) contracts, each contract minimum valued at US\$ 510,959.01 or BDT 48,000,000.00 with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).

- The minimum average annual turnover of US\$ 1,916,096.27 or BDT 180,000,000.00 calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years.

The complete eligibility and qualification requirements are stipulated in the Bidding Documents.

The Bidding Document, in the English language, may be purchased directly or through authorized representative of interested Bidders upon submission of a written application to the address above and upon payment of a non-refundable fee BDT 5,000.00 or US\$ 60.00. The method of payment will be in Demand Draft/Pay Order in favor of the “Dhaka Water Supply Network Improvement Project (DWSNIP)”. The Bidding Document may be collected in person or may be sent by express airmail for an additional fee of BDT 300.00 for domestic delivery or US\$ 80.00 for overseas delivery. No liability will be accepted for loss or late delivery.

7. Bids must be delivered to the address above **on or before 22 August 2022, 14:00 hours (Bangladesh Standard Time)** accompanied by a Bid Security, as described in the Bidding Document. Bids will be opened at 14:30 hours on same day in the presence of Bidders’ representatives who choose to attend.

8. A Pre-Bid Meeting will be held at **11:00 hours** (Bangladesh time) on **1 August 2022** at DWASA Conference Center, 3rd Floor, WASA Bhaban, Dhaka, Bangladesh.

9. The Purchaser will not be responsible for any cost or expense incurred by Bidders in connection with the preparation or delivery of bids.

10. When comparing Bids, ADB’s Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the Bidding Document.
