The People's Republic of Bangladesh has received a loan from the Asian Development Bank (ADB) toward the cost of **COVID-19 Response Emergency Assistance Project**, and it intends to apply part of the proceeds of this loan for payments under the contract named above. This contract will be jointly financed by ADB and the People's Republic of Bangladesh. The eligibility rules and procedures of the ADB will govern the bidding process.

2. The **Directorate General of Health Service** (DGHS, the "Purchaser") invites quotations from eligible bidders/suppliers for the **Procurement of Emergency Medical Supplies** (the "Goods") under the project. Goods are to be delivered to designated place mentioned in the Request for Quotation (RFQ) document summarized below. Bidders/suppliers may participate in one, or both the contracts (Lots).

Only eligible Bidders/suppliers with the required qualifications should participate in this bidding. To obtain RFQ document, eligible bidders/suppliers are required to send e-mail request to the address below submitting proof of having adequate manufacturing/ supply capacity/availability of ready stock. RFQ document can be requested up to 16:00 Hours BST on 24 June 2020, after which no request will be accepted.
