The Royal Government of Cambodia (RGC) has received financing from Asian Development Bank (ADB) toward the cost of **Rural Roads Improvement Project II**, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Ministry of Rural Development** (“the Employer”) invites sealed bids from eligible Bidders for the construction and completion of the following contract package (“the Works”).

3. **Open Competitive Bidding (International Advertisement)** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Documents.
