

Invitation for Bids

1. The **Royal Government of Cambodia (RGC)** a loan from the Asian Development Bank (ADB) toward the cost of Urban Water Supply Project, and intends to apply part of the proceeds of this loan to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Siem Reap Water Supply Authority (SRWSA)** (“the Purchaser”) invites sealed bids from eligible Bidders for the **Supply and Delivery of Siem Reap Provision of Equipment**.
3. **National Competitive Bidding (NCB)** will be conducted in accordance with the ADB’s [Single Stage – One Envelope](#) procedure and is open to all eligible Bidders as described in the Bidding Document.
4. Qualification requirements include the following:
 - Copies of original documents defining the constitution or legal status, place of registration, and principal place of business evidencing legal status in an eligible source country as defined in GCC Sub-Clause 6.1.
 - In the case of a Bidder offering to supply goods under the contract which the Bidder do not manufacture or otherwise produce, the Bidder has been duly authorized by the goods’ manufacturer or producer to supply the goods in Cambodia.
 - The Bidder shall furnish documentary evidence that it meets the following experience and financial requirements:
 - that the Bidder has satisfactorily completed at least two (2) contracts for supply of similar goods in the preceding three (3) years or not less than 50 percent of the bid price in each contract.
 - that the Bidder has completed contracts in the total accumulative amount equal to at least two (2) times the value of bid price in the preceding two (2) years.
 - that the Bidder has availability of liquid assets through either:
 - access to a line of credit or cash in a bank account of an amount at least 50 percent of the bid price, net of other contractual commitments;

- credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least six (6) months after the deadline for submission of bids specified in ITB Clause 21.

Sub-contractors' qualifications shall not be taken into account in establishing the Bidder's qualifications to perform the contract.

- that, in the case of a Bidder not doing business within Cambodia, the Bidder is or will be (if awarded the contract) represented by an agent in Cambodia equipped and able to carry out the Supplier's maintenance, repair, and spare parts stocking obligations described in the Conditions of Contract and/or Technical Specifications and
 - that the Bidder gives to the Purchaser the authority to seek references from the Bidder's bankers.
