1. The Royal Government of Cambodia (RGC) has received a loan from the Asian Development Bank toward the cost of Upper Secondary Education Sector Development Project (USESDP), and it intends to apply part of the proceeds of this loan to payments under the Contract named above. Bidding is open to bidders from eligible source countries of ADB.

2. The **Ministry of Education, Youth and Sport (MoEYS)**, Cambodia invites sealed bids from eligible bidders for the **Construction of Upgrading of 6 USS to Secondary Resource School by constructing 6 secondary resource centers in Kampong Cham, Kratie, Kampong Thom, Banteay Meanchey, Battambang, and Oddor Meanchey**. The construction period is **300 days**.

3. **National Competitive Bidding (NCB)** will be conducted in accordance with ADB's [Single-Stage One Envelope](#) procedure and is open to all bidders from eligible countries as described in the Bidding Document.

4. Interested eligible bidders may obtain further information from and inspect the Bidding Documents at the address given below from **8:00 to 12:00 hours in the morning and from 14:00 to 17:00 hours** on working days.

5. Only eligible bidders with the following key qualifications should participate in this bidding:

- The average annual volume of construction work of the successful bidder over the last three (3) years shall be **\$3,800,000.00**
- The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful bidder shall be: **\$570,000**

- The essential equipment required for **USESDP-W-02** are:

- If the bidder is a contractor in any of the construction contract under this project (Upper Secondary Education Sector Development Project (USESDP) under ADB Loan No. 3427) for which the construction period has not yet been completed, the qualification requirements mentioned in 6.3(a), 6.3(c) and 6.3(d) will be cumulative to the current package requirement and the ongoing awarded contract under this project.
- The Contract Manager should be with Civil Engineering background and should have at least five (5) years of experience in handling works at multiple locations in a single contract.

The RGC and the Asian Development Bank will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract funded by the RGC and/or Asian Development Bank, if they at any time determines that the firm has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in completing or in executing a contract.
