1. The **Royal Government of Cambodia (RGC)** has received a loan from the Asian Development Bank (ADB) toward the cost of **Greater Mekong Subregion Health Security Project** and intends to apply part of the proceeds of this loan to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Ministry of Health** (“the Purchaser”) invites sealed bids from eligible Bidders for the **Supply of (i) Lot 1: 13 units of Vehicle Pick-up, and (ii) Lot 2: 2 units of Ambulance.** Bidders may bid for one lot or both.
3. **National Competitive Bidding (NCB)** will be conducted in accordance with ADB’s [Single Stage – One Envelope](#) procedure and is open to all bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - The Bidder shall furnish documentary evidence that it meets the following experience and financial requirements:
 - i. that the Bidder has satisfactorily completed at least two (2) contracts for supply of similar goods in the preceding three (3) years of not less than 50 percent of the bid price in each contract.
 - ii. that the Bidder has completed contracts in the total cumulative amount equal to at least two times the value of the bid price in the preceding two (2) years.
 - iii. that the Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least three (3) years in the manufacturing of similar goods.
 - iv. that the Bidder has availability of liquid assets through either: (a) access to a line of credit or cash in bank account of an amount at least 50 percent of the bid price, net of other contractual commitments; or (b) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
 - That, in the case of a Bidder not doing business within Cambodia, the Bidder is or will be (if awarded the contract) represented by an Agent in Cambodia equipped and able

to carry out the Supplier's maintenance, repair, and spare parts stocking obligations prescribed in the Conditions of Contract and/or Technical Specifications;

- That the Bidder gives to the Purchaser the authority to seek references from the Bidder's bankers.
5. A complete set of Bidding Documents in English may be purchased by interested Bidders on the submission of a written application to the address given below and upon payment of a **non-refundable fee of USD 35 or its equivalent in Cambodian Riel 143,500.00**. The method of payment will be in cash or deposit to Bank Account No. 000000016940 of National Bank of Cambodia. The Bidding Documents may be collected in person or may be sent by email or courier, but the Bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate at the discretion of the Bidder. Other than payment of non-refundable fee, there are no other conditions for the purchase of the Bidding Documents. No liability will be accepted for loss or late delivery.
