The Kingdom of Cambodia has received financing from the Asian Development Bank (ADB) towards the cost of **Climate-Friendly Agribusiness Value Chains Project (CFAVC)** and it intends to apply part of the proceeds of this loan and grant to payments under the contract named above. No nationality restrictions apply.
2. The **Ministry of Agriculture, Forestry and Fisheries (MAFF) of Cambodia through its Project Management Unit (PMU)** invites sealed bids from eligible Bidders for the **Construction of Agricultural Cooperatives Storage – 8 units in Kampot province and 13 units in Takeo province**. The construction period is 150 days or five (5) months. Bidders may bid for one or both lots.
3. **National Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) procedure and is open to all Bidders without nationality restrictions.
4. Bidder's attention is drawn on the following key qualification criteria:
  - Average Annual Construction Turnover: The average annual volume of construction work over the last three (3) years (2019, 2020, and 2021) shall be at least:
    - Lot 1: USD1,396,807.50
    - Lot 2: USD2,286,864.00
    - For Lots 1 and 2: USD3,665,671.50
  - Specific Similar Experience: Experience as prime contractor in the construction of at least two (2) contract(s) for works of nature and complexity equivalent to the Works with each contract value of at least within the last five (5) years:
    - Lot 1: USD 698,403.75
    - Lot 2: USD1,134,432.00
    - For Lots 1 and 2: USD1,832,835.75
  - Liquid Assets: The minimum amount of liquid assets or working capital or credit facilities of the Bidder shall be:
    - Lot 1: USD 558,723.00

- Lot 2: USD 907,545.60
- For Lots 1 and 2: USD1,466,268.60
