1. The Kingdom of Cambodia has received financing from the Asian Development Bank (ADB) towards the cost of **Fourth Greater Mekong Subregion Corridor Towns Development Project**. A portion of this financing will be applied for eligible payments under the contract named above. The bidding is open to Bidders from eligible source countries of the ADB.
2. The **Ministry of Public Works and Transport (MPWT)** (“the Employer”) hereby invites sealed bids from eligible Bidders for the construction and completion of the following contract package (“the Works”):

The Works include:

- Upgrading of 1,450 meters of external access road to the landfill site.
- Construction of one (1) controlled landfill cells out of a total of two (2) cells.
- Construction of one (1) hazardous waste landfill cell.
- Construction of a non-mechanical type of material recovery facility (MRF): 910 sq.m.
- Construction of drainage, leachate collection, treatment, and recirculation system.
- Construction of weighbridge, office, staff dining and rest room (combined building).
- Workshop, electrical and mechanical room, and supply building.
- Construction of concrete internal roads with associated bunds and drainage.
- Construction of wire mesh fencing, brick entrance wall, gate, and security guardhouse.
- Construction of car/ vehicle washing facility.
- Construction of hazardous waste storage building.
- Provision of utilities, including construction of grid-tied solar system.
- Provision of operations and maintenance (O&M) equipment.

3. **International Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualification should participate in this Bidding:
 - The Bidders' net worth within last year shall be positive.
 - Minimum average annual construction turnover of US\$8.91 million calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2018-2019 & 2020).
 - The Bidder must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of US\$1.11 million.
 - Participation in at least one (1) contract that has been successfully or substantially completed within the last five (5) years and that is similar to the proposed works, where the value of the Bidder's participation exceeds US\$5.05 million.

The qualification criteria are more completely described in the Bidding Document.

6. To purchase the Bidding Documents in English, eligible Bidders should:
 - Write to address above requesting for the Bidding Documents for the Contract Package No. PMU/MPWT/CTDP4/ICB/CW05.
 - Pay a non-refundable fee of US\$250 or its equivalent in Cambodian Riel being 1,000,000.00 Riel. The method of payment will be in cash or deposit to Bank account No.000000001333 of National Bank of Cambodia.

The Bidding Documents may be collected in person, or may be sent by email or courier, at the discretion of the Bidder, but the Bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate. Other than payment of the non-refundable fee specified above, there shall be no other conditions for the purchase of the Bidding Documents.

The Bidding Documents can be purchased during normal working days from between 8:00-11:30 hours in the morning and 14:30-17:00 hours in the afternoon at the address indicated in para 5 above.

7. Deliver bids:
 - to the address above

- **on or before the deadline: 3 November 2021, 10:00 hours local time**
- together with a Bid Security as specified in the Bidding Documents. For the purpose of determining the equivalent amount of the required Bid Security in a freely convertible currency, the selling exchange rate published by the National Bank of Cambodia on the date 28 days prior to the deadline for bid submission shall be applied.

Bids will be opened immediately after the deadline, in the presence of Bidders' representatives who choose to attend.

The Bidder shall bear all costs associated with the preparation and submission of its bids and the Employer shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
