The Royal Government of Cambodia (RGC) has received a loan from the Asian Development Bank (ADB) toward the cost of **Second Upper Secondary Education Sector Development Program (USESDP-2)** and it intends to apply part of the proceeds of this loan to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Ministry of Education, Youth and Sport** invites sealed bids from eligible Bidders for the **GD4107: Procurement of Goods Supply and Delivery of 08 Pick-up Double Cabin Vehicles**.
3. **National Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with following key qualifications should participate in this bidding:
 - That the Bidder has satisfactorily completed at least two (2) contracts for supply of similar goods in the preceding three (3) years of not less than 50 percent of the bid price in each contract,
 - That the Bidder has completed contracts in the total cumulative amount equal to at least two times the value of the bid price in the preceding two (2) years,
 - Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least three (3) years in the manufacturing of similar goods,
 - That the Bidder has availability of liquid assets through either:
 - access to a line of credit or cash in bank account of an amount at least 50 percent of the bid price, net of other contractual commitments, OR
 - credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least six (6) months after the deadline date for submission of bids specified in ITB Clause 21.
5. The method of payment will be cash. The Bidding Documents may be collected in person at the discretion of the Bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for purchase of the Bidding Documents.

The Royal Government of Cambodia and/or the Development Partner will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract funded by the Royal Government of Cambodia and/or the Development Partner respectively, if it at any time it is determined that the Bidder has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in completing or in executing a contract.
