1. The Royal Government of Cambodia (RGC) has received a loan from the Asian Development Bank toward the cost of Skills for Competitiveness Project (S4C), and it intends to apply part of the proceeds of this loan to payments under the Contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
2. The **Project Management Unit of Ministry of Labour and Vocational Training (MLVT)** invites sealed bids from eligible Bidders for the **Construction of 3 new buildings and rehabilitation of 2 existing building at Battambang Institute of Technology (BIT), Battambang Province**. The construction period is 18 months from date of notification to commence.
3. **Open Competitive Bidding (National)** will be conducted in accordance with the ADB's [Single Stage – One Envelope](#) bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Documents.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - Bidders with US\$ 6,380,000 average annual volume of construction work over the last three years (2016, 2017 & 2018).
 - Bidders with experience as prime contractor or sub-contractor in the construction of at least two (2) works of a similar nature or complexity equivalent to the works within the last five years, and with minimum contract amount of US\$2,395,000. To comply with this requirement, works cited should be at least 70 percent complete, billed and paid and documentary evidence must be submitted with the bid.
 - Bidders with minimum amount of liquid assets and/or credit facilities net of other contractual commitments of US\$ 532,000.
 - Bidders with valid registration from the Ministry of Commerce (MOC), and Land Management Urban Planning and Construction (LMUPC) or Ministry of Public Works and Transport (MPWT), and a valid registration/permit /patent issued by the Ministry of Economy and Finance (MEF).
 - Bidders with duly audited financial statements by an independent firm, for the last three (3) years (2016, 2017 & 2018) demonstrating soundness of its financial position. As a minimum, the Bidder's net worth for the last three (3) years calculated

as the difference between total assets and total liabilities should be positive. The financial statements and its audit should not violate the relevant national statutory accounting standards.

The qualification criteria are more completely described in the Bidding Document.

5. The method of payment will be in cash or deposit to Bank account No.000000001333 of National Bank of Cambodia. The Bidding Documents may be collected in person, or may be sent by email or courier, at the discretion of the Bidder, but the Bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate. Other than payment of the non-refundable fee specified above, there are no other conditions for the purchase of the Bidding Documents.

The Government of Cambodia and Asian Development Bank will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract funded by the Government of Cambodia and/or Asian Development Bank, if it at any time it determines that the firm has engaged in corrupt or fraudulent, coercive or collusive practices in competing for or in executing a contract.
