1. The Republic of Fiji has received financing from the Asian Development Bank (ADB) toward the cost of Transport Investment Infrastructure Sector Project. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. **The Fiji Roads Authority (“the Employer”)** invites sealed bids from eligible Bidders for the construction and completion of Queens Road Upgrading Project (QRUP) Contract B (“the Works”).
3. Open Competitive Bidding (OCB) International will be conducted in accordance with ADB’s Single Stage Two Envelope procedure and is open to all Bidders from eligible countries as described in the Bidding Document. **The evaluation will follow a Quality Cost Based System (QCBS) with 70% allocated to Technical Score and 30% allocated to Price Score.**

Only eligible Bidders with the following key qualifications should participate in this bidding:

- Minimum average annual construction turnover of FJD \$25,000,000 calculated as total certified payments received for contracts in progress or completed, within the last three years.
 - Participation as a contractor, Joint Venture partner, or Subcontractor, in at least one contract that has been successfully or substantially completed within the last 10 years and that is similar to the proposed works, where the value of the Bidder’s participation exceeds FJD \$16,000,000. The similarity of the Bidder’s participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6, Employer’s Requirements.
 - In-situ stabilization using cement, lime or other stabilization agents **using machines and methods in compliance with the Employers Requirements** in a single contract of not less than 10,000m³.
 - **Procurement and laying** unbound crushed aggregate pavement in a single contract of not less than 20,000m³.
 - **Procurement or production** of asphalt wearing course in a single contract of not less than 4,600 tonnes
 - Laying of asphalt wearing course in a single contract of not less than 40,000 m².
 - Application of double bituminous surface dressing in a single contract not less than 20,000m².

- together with a Bid Security as described in the Bidding Document.

Technical Bid Envelops will be opened immediately after the deadline for bid submission in the presence of Bidders' representatives who choose to attend.

7. Bids must be submitted electronically via Tenderlink on or before 2:00pm (Fiji Local time) on 23 March 2021. Late bids will not be accepted. Bids will be opened immediately after the deadline at the address indicated below in the presence of Bidders' representatives who choose to attend. **Hard Copy Submission is not allowed**
