1. India has received financing from the Asian Development Bank (ADB) toward the cost of **Railway Sector Investment Program – Tranche 1**. Part of this financing will be used for payments for works under the contracts named above. Bidding is open to eligible bidders from eligible source countries of the ADB.

2. **RAIL VIKAS NIGAM LIMITED** (the “Employer”) now invites sealed bids from eligible bidders for the following works:

*Execution of balance work of roadbed, major and minor bridges and track linking including electrical work in connection with doubling between Hubballi to Dharwad (km 469.00 to 489.09), construction of quarters, service buildings and residual works for commissioning of doubling in between Harlapur and Hebsur (km-74.00 to km 18.97) and Hubballi to Dharwad (km 469.00 to km 489.09) on Hubballi division of South Western Railway in Karnataka state, India*
