The Government of India has applied for a loan from the Asian Development Bank (ADB) towards the cost of **Himachal Pradesh Clean Energy Transmission Investment Program – Tranche 3** and it is intended that part of this loan will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **HP Power Transmission Corporation Ltd.** (“the Employer) invites sealed bids from eligible bidders for the “**Design, Engineering, Manufacture, Fabrication, Testing at Manufacturers Works, Transportation to Site, Insurance, Loading and Unloading, Storage, Erection, Testing and Commissioning of 2 Nos AIS Bays and LILO of 2nd Circuit of 220 kV Kunihar- Panchkula Transmission Line at 220 kV Sub Station Baddi in Solan District of Himachal Pradesh on Turnkey Basis (Complete Package).**” The completion period is 12 Months.
3. **International Competitive Bidding** will be conducted in accordance with ADB’s Single-Stage: Two-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.

7. Bidders must deliver their bids to the address above **at or before 15:00 hours on 27 July 2019** together with a Bid Security as indicated in the Bidding Documents.

Technical bids will be opened on 27 July 2019 at 15:30 hours (local time) in the presence of Bidders' representatives who choose to attend at the address above, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after Technical Bid Evaluation, whereas, the Financial Bids of those Bidders whose Technical Bids are not responsive and qualified shall be returned unopened after the contract is awarded.

8. The Employer will not be responsible for costs or expenses incurred by Bidders in connection with the delivery or preparation of bids.
