1. The Government of India has applied for financing from the Asian Development Bank (ADB) toward the cost of **Uttarakhand Integrated Urban Development Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

The “**Program Director**”, **Uttarakhand Urban Sector Development Agency (UUSDA), Government of Uttarakhand**” (the Employer) invites online bids through the Uttarakhand state e-procurement portal <https://uktenders.gov.in>, from eligible Bidders for the design, execution, commissioning and O&M of the work as detailed below:

3. **Open Competitive Bidding (national advertisement)** will be conducted in accordance with ADB’s [Single-Stage: Two-Envelope](#) bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Documents.

7. Submission of bid:

- For submission of the bid, the Bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorised by Government of India for issuing DSC.

Aspiring Bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://uktenders.gov.in>. Any Bidder not having the DSC may obtain the same from NIC on payment of requisite fees, before the bid submission deadline.

- **Bids must be submitted online on <https://uktenders.gov.in> on or before 12 February 2021, up to 15:00 hours and the 'Technical Part' of the bids will be opened publicly online on the same day at 15:30 hours (IST).** The "Financial Part" shall remain unopened in the e-procurement system until the public bid opening for the financial part. Any bid or modification to bid (including discount) received outside e-procurement system will not be considered.
- All bids must be accompanied by a Bid Security as specified in paragraph 2 and shall have to be valid for 28 days beyond the validity of the bid. The Bidder shall furnish a bid security for the amount as mentioned in the table above, using the instruments specified in ITB 19.3 and submit it online, on or before the bid submission deadline.

Technical Bids will be opened immediately after the deadline for bid submission in the presence of Bidders' representatives who choose to attend.

8. The Employer will not be responsible for any cost or expense incurred by Bidders in connection with the preparation or delivery of bids.
