



Invitation for Bids – Rebidding

1. The Government of India has received financing from the Asian Development Bank (ADB) toward the cost of **Assam Power Sector Investment Program - Tranche 3**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Assam Power Generation Corporation Limited (APGCL)** (“the Employer”) invites sealed bids from eligible Bidders for **Installation and establishing Network Connectivity between Data Centre (DC)-Disaster Recovery (DR) Centre and APGCL locations** (“the Works”).
3. **International Competitive Bidding** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Documents.
4. To be qualified for the contract package, the Bidder should as a minimum meet the following requirements:

Financial:

- Minimum average annual turnover of INR 5.3 Crores within the last three (3) years.
- The Bidder must demonstrate access to cash-flow requirement of INR 1 Crores.

Contractual Experience

- Successful completion as main supplier within the last three (3) years of at least one (1) similar contract each valued at INR 2 Crore from Government/Public Sector Organization with nature, and complexity similar to the scope of requirements described in Section 6 (Schedule of Requirements).

Technical Experience

- The Bidder shall demonstrate that the IT products offered have operational network in Assam at the time of bidding with valid telecom license to operate in Assam for next three (3) years.

Other mandatory requirements

- The Bidder should be registered with Indian Goods and Services Tax Network (GSTIN).
- The Bidder should have existing network in locations (APGCL sites) as mentioned in Section 6.
- 100 percent of the total mandatory requirements should be “Yes” in the requirement specifications as mentioned in Section 6: Technical Requirement Specifications.

For complete eligibility and qualification requirements, interested Bidders should refer to the Bidding Document.

5. Interested Bidders may obtain further information on the bid from Government of Assam e-procurement portal (<https://assamtenders.gov.in>) and APGCL website- www.apgcl.org.

6. The Bidding Document will remain available at the e-procurement website (<https://assamtenders.gov.in>) during the bidding period and the same can be downloaded for free. However, at the time of Bid Submission, the Bidder shall pay a non-refundable fee of Rs 5000 (Indian Rupees Five Thousand Only) as Tender Processing Fee online.

7. A pre-bid conference/meeting will be held as indicated in the Bidding Document on 11 May 2022 at 12:30 hours (IST).

8. Bids should be submitted online through e-procurement portal (<https://assamtenders.gov.in>) only **at or before 12:30 hours (IST) on 15 June 2022**.

9. Bids shall be opened online, and the Bidders may view the status of bid opening online in the e-Tendering platform. Maximum two (2) nos. of authorized designated representative of the Bidders may also choose to attend at the address mentioned below at 15:30 hours (IST) of 15 June 2022.

Bidders are required to submit original copy of the Bid Security in APGCL Office address on or before due date and time for bid opening. A bid will be rejected if original copy of the bid security does not reach APGCL office on or before the due date and time for bid opening.
