1. India (hereinafter called “Borrower”) has applied for financing from the Asian Development Bank (ADB) toward the cost of Madhya Pradesh Irrigation Efficiency Improvement Project. Part of this loan will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The Chief Engineer, Project Implementation and Coordination Unit, Madhya Pradesh Water Resources Department, Bhopal (M.P.), India (the “Employer”) invites sealed bids from eligible Bidders for the Design, executing, completion and operation of Design, Supply, Installation and Operation of Kundalia Irrigation Project – Left Bank.

3. International Competitive Bidding (ICB) will be conducted in accordance with ADB’s [Single-Stage: Two-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- (i) Has average annual construction turnover of US\$ 130 million for last 5 years
- (ii) Has available cash flow as per FIN-4 of document plus US\$ 17 million
- (iii) Has experience as contractor within last 10 years for at least 1 contract amounting to US\$100 million that have been successfully or are substantially completed
- (iv) For the above contract(s), has specific experience of having completed:
  - Supply and installation of steel pressure pipes of not less than 2m diameter, of not less than 10 km length in past 10 (ten) years.
  - Construction of an irrigation system of a pipeline or canal irrigation system of at least 10,000 ha.

6. To purchase the Bidding Document in English, eligible Bidders should:
- a) Write to address above requesting the Bidding Document for the Design, Supply, Installation and Operation of Kundalia Irrigation Project – Left Bank.
  - b) As per State Government Order no. 1785 of year 2009, potential bidders are obliged to pay a non-refundable fee of INR50,000 (Rupees Fifty Thousand only) or equivalent US\$850 in the form of demand draft in favor of Executive Engineer, Bahya Vitta Poshit Pariyojanayen, Water Resources Department payable at any Scheduled Bank in Bhopal, Madhya Pradesh, India. If the Bidding Document is desired by courier/ post, an additional sum of INR1000 for dispatch of Bidding Document anywhere in India or US\$100 for dispatch outside India, should be sent. The Employer shall promptly dispatch the Bidding Documents by courier/post, but under no circumstances shall be held responsible for late delivery or loss of documents.

In case the Bidder submits a bid based on the downloaded document, it should be accompanied with a Demand Draft of INR 50,000/- (Rupees Fifty Thousand only) or US \$850 in the form of demand draft in favour of Executive Engineer, Bahya Vitta Poshit Pariyojanayen, Water Resources Department payable at any Scheduled Bank in Bhopal, Madhya Pradesh, India.

  - on or before the deadline IST 1500 hours on 1 August 2017.
  - together with a Bid Security as described in the Bidding Document.

Late bids shall be rejected.

Bids will be opened immediately after the Bid submission deadline in the presence of Bidders' representatives who choose to attend.
