



## Invitation for Bids

1. The Government of India has applied financing from Asian Development Bank (ADB) toward the cost of **Urban Flood Management for Chennai Kosasthalaiyar Basin Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.

2. The **Greater Chennai Corporation, Chennai, Tamilnadu** (“the Employer”) invites online bids from eligible Bidders for the **Construction of integrated storm water drain in Retteri Lake Watershed in Kosasthalaiyar basin in the extended areas of Greater Chennai Corporation (Package 7 - Outfall 1, Part -2)** (“the Works”).

3. **Open Competitive Bidding (National Advertisement)** will be conducted in accordance with ADB’s [Single-Stage: Two-Envelope](#) bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- Bidder’s net worth for the last year (FY 2018-19) calculated as the difference between total assets and total liabilities should be positive.
- Average annual construction turnover of INR 489 million (INR 4890 Lakhs) or its equivalent calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (Financial Year 2016-17, 2017-18 & 2018-19) or as per international practice (FY2017, FY2018, FY2019).
- Bidder’s financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of INR 81 million (INR 810 Lakhs)
- Participation as a contractor, Joint Venture partner, or Subcontractor, in at least one (1) contract that has been successfully or substantially completed and that is similar to the proposed works, where the value of the Bidder’s participation exceeds INR 402 million (INR 4020 Lakhs) within the period from 1 July 2013 up to the bid submission date.
- Meet other financial and experience requirements as indicated in the Bidding Document. However, for complete eligibility and qualification requirements, interested Bidders should refer to the Bidding Document.
