1. The Government of India has applied for financing from the Asian Development Bank (ADB) toward the cost of **Integrated Urban Flood Management for Chennai Kosasthalaiyar Basin Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Greater Chennai Corporation, Chennai, Tamil Nadu** (“the Employer”) invites sealed bids from eligible Bidders for the **Construction of integrated storm water drain in Puzhal Surplus South Watershed of Kosasthalaiyar basin in the extended areas of Greater Chennai Corporation** (Package 24 - Outfall GP9 and GP10) (“the Works”).
3. **Open Competitive Bidding (national advertisement)** will be conducted in accordance with ADB’s [Single-Stage: Two-Envelope](#) bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Documents.
4. To be qualified for the contract package, the Bidder should as a minimum meet the following requirements:
 - Bidder’s net worth for the last year calculated as the difference between total assets and total liabilities should be positive
 - Average annual construction turnover of INR 572.00 million (INR 5720.00 Lakhs) or its equivalent calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (Financial Year 2017-18, 2018-19 & 2019-20) or as per international practice (FY2017, FY2018, FY2019). If audited financial statements for FY 2019-20 is not available, financial statements for FYs 2016-17, 2017-18, and 2018-19 may instead be submitted
 - Bidder’s financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of INR 96.00 million (INR 960.00 Lakhs).
 - Participation as a contractor, Joint Venture partner, or Subcontractor, in at least one (1) contract that has been successfully or substantially completed and that is similar to the proposed works, where the value of the Bidder’s participation exceeds INR 572.00 million (INR 5720 Lakhs) within the period from 1 July 2013 up to the bid submission date.
