Bidding is open to Bidders from eligible source countries of ADB.

- b) Bidders should be in possession of Class III Digital Signature Certificate (DSC) in the name of the person duly authorized to sign on behalf of the Bidder from any of the licensed Certifying Agency (CA). - To the address in Para 4 above. However, the Bidder **shall not** submit Financial Bid in hard copy (i.e. Financial Quote is to be uploaded on <http://eproc.rajasthan.gov.in> portal along with the technical bid).
- On or before 5 July 2018 by 11:30 Hrs. IST.
- Bidders shall also submit the following in hard copies:
  - (i) a non-refundable Bid Document Fee of INR 50,000 in the form of Demand Draft or Bankers Cheque payable at Jaipur in favor of “Project Director (PPP), PWD, Jaipur”, if downloaded from websites.
  - (ii) a non-refundable Processing Fee of INR 1,000 in the form of Demand Draft or Bankers Cheque in favor of “MD RISL” payable at Jaipur.
  - (iii) Bid Security in the amount and form as described in ITB Section-1 Clause-19 and Section-2 Clause-19.1

- b) The Employer will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of their Bids.
  - c) Technical bids shall be opened/downloaded on 5 July 2018 at 12:30 Hrs. IST in the presence of the Bidders' representatives who choose to attend at the PPP Division - Public Works Department, 1 Jacob Road, Civil Lines, Jaipur-302006, Rajasthan.
