1. The Government of India has applied for financing from the Asian Development Bank (ADB) towards the cost of **Meghalaya Power Distribution Sector Improvement Project**. Part of this financing will be used for payments under the contracts named above. Bidding is open to Bidders from eligible source countries of ADB.

2. **Meghalaya Power Distribution Corporation Ltd (MePDCL** the “Employer”) invites online bids from eligible Bidders for the below-mentioned contract package.

3. **Open Competitive Bidding – International** will be conducted in accordance with ADB's [Single-Stage: Two Envelope](#) bidding procedure and is open to all bidders from eligible source countries of the ADB.

4. Only eligible Bidders with the following qualifications should participate in this bidding:
- Design, supply, construction, installation, testing and commissioning of 33 kV or above voltage class new AIS / GIS substation/s.
 - Augmentation, renewal or extension of existing 33 kV or above voltage class AIS/GIS substation/s.

- c. Successful and substantial completion of at least 30 numbers of new or augmentation/ renewal or extension of existing 33kV voltage or above AIS / GIS substations during the last ten (10) years from the bid submission deadline.

- Bidders will have to register their firm/Joint Venture with e-procurement portal of <https://meghalayatenders.gov.in/nicgep/app> to have a user ID and password.
 - Bidders should be in possession of Class II / Class III Digital Signature Certificate (DSC) in the name of the person duly authorized to sign on behalf of the Bidder from any of the licensed Certifying Agency (CA).
 - Bidders who already have a valid Digital Certificate need not procure a new Digital Certificate.

Technical and Financial Bids must be submitted in electronic format at e-Tendering portal <https://meghalayatenders.gov.in/nicgep/app> in accordance with the procedure for online submission as detailed in the Bid Data Sheet **on or before 15 January 2020 up to 14:30 hours IST**. Bids submitted through any other mode shall not be accepted.
9. Bidders shall submit the following documents in original/hard copies on or before the scheduled bid submission deadline:
- a non-refundable Bid Document Fee of INR 25,000/-/Equivalent amount of US \$ 350 (incl GST) by Demand Draft / Banker's Cheque in favour of "MeECL Principal Account", payable at "Shillong"
 - Bid Security in the amount and form as described in ITB Section-1 Clause-21 and Section-2 Clause-21.
10. The Employer will not be responsible for any cost or expense incurred by Bidders in connection with the preparation or delivery of their Bids.
11. Technical bids shall be downloaded and opened on **15 January 2020 at 15:00 hours IST** in the presence of the Bidders' representatives who choose to attend at the Conference Hall, MeECL, Lumjingshai, Shillong, Meghalaya, India, PIN: 793001.
