1. India (hereinafter called "Borrower") has applied for financing from the Asian Development Bank toward the cost of **Promoting Public-Private Partnership in Madhya Pradesh Road Sector Project**. Part of this financing will be used for payments under the contracts named below. Bidding is open to Bidders from eligible source countries of ADB.

2. **M.P. State Road Development Corporation Limited**, a fully owned Company of Government of Madhya Pradesh registered under Companies Act, 1956, invites online bids from eligible Bidders for the **Rehabilitation and Upgradation of following Civil Work Contract Packages** (the works).

3. Bidders may bid for one or more contract packages, as defined in the Bidding Document. Separate bids shall be required for each package.

4. **Open Competitive Bidding (National Advertisement)** will be conducted in accordance with ADB's [Single-Stage: Two-Envelope](#) bidding procedure and is open to all Bidders from eligible source countries.

5. The complete Bidding Document can be viewed/downloaded by the Bidder from the e-procurement portal <https://mptenders.gov.in> at no cost.

7. To participate in the bidding process:

- Register with e-procurement portal <https://mptenders.gov.in> for obtaining user ID and password. The user manual, guidelines and FAQ are available on the MP eProcurement website to facilitate understanding and use. Registration requires a registration fee of INR 500/- (Five Hundred Rupees Only) (please check the prevailing amount on the portal) through the e-payment gateway. Further, Tender Processing Fees for MP eProcurement portal (please check the prevailing amount on the portal) shall also need to be paid through the e-payment gateway.
- Purchase the Bidding Document online through portal by payment of a non-refundable document fee of INR 50,000/- (Rupees Fifty Thousand only) and processing fee for each Package through e-payment gateway. The Document shall be available for sale during office hours from **30 November 2019 (17:30 hours IST) to 4 January 2020 (12:30 hours IST)**
- Use valid digital certificates issued by the National Certificate Authorities (list of authorized certifying authority is available on web site) for purchasing and bid submissions.

8. Deliver bids:

- Online through the MP eProcurement portal: <https://mptenders.gov.in>
- **On or before 12:30 hours (IST) on 4 January 2020.**
- Detailed guidelines for MP eProcurement are available on the MP eProcurement portal
- The required bids will need to be prepared and scanned in different files (in PDF or JPEG format) and uploaded into the relevant online folders.

- Apart from the online submission, supporting original documents including bid security have to be submitted in physical form in accordance with ITB 21.1 (a) **on or before 12:30 hours (IST) on 4 January 2020.**
 - Technical Bids will be opened **online on 12:30 hours (IST) on 4 January 2020** as detailed in Para 25 of ITB of the Bidding Documents at MPRDC office (45-A, Arera Hills, Bhopal) in the presence of Bidders' representatives who choose to attend. In the event of the specified deadline for bid submission being declared a Government Holiday, the next official working day would be deemed as the last day for the Physical submission of bids.
9. A Pre-bid meeting will be held at the Office of Managing Director, M.P. Road Development Corporation Ltd., 45-A, Arera Hills, Bhopal (M.P) on 12 December 2019 at 11:30 hours. The clarification/ addendum/ corrigendum (if any) shall be published on the website <https://mptenders.gov.in> only.
