Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

- Bidders will have to register their firm/Joint Venture with e-procurement portal of <https://etender.up.nic.in/nicgep/app> to have a user ID and password.
- Bidders should be in possession of Class III Digital Signature Certificate (DSC) in the name of the person duly authorized to sign on behalf of the Bidder from any of the licensed Certifying Agency (CA). Bidders are required to submit only Bid Document Fee and Bid Security in hard copy on or before scheduled deadline for submission of bids.

On or before the time of Bid Submission on 13 August 2019 by 14:00 hours IST, Bidders shall submit the originals (hard copies) of the following:
