



## Invitation for Bids

1. The Government of India has applied for financing from the Asian Development Bank (ADB) towards the cost of **Uttar Pradesh Power Distribution Rehabilitation Project (UPDRP)**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Pashchimanchal Vidyut Vitran Nigam Ltd, Meerut** (PVVNL the “Employer”) invites online bids from eligible Bidders for the below-mentioned contract package:

- Bidders should be in possession of Class III Digital Signature Certificate (DSC) in the name of the person duly authorized to sign on behalf of the Bidder from any of the licensed Certifying Agency (CA). Technical and Financial Bids must be submitted in electronic format at e-Tendering portal: <https://etender.up.nic.in/nicgep/app> in accordance with the procedure for online submission as detailed in the Bid data Sheet on or before 21 August 2019 up to 14:00 hours IST. Bids submitted through any other mode shall not be accepted. Bidders are required to submit only Bid Document Fee and Bid Security in hard copy on or before scheduled deadline for submission of bids.

On or before the time of Bid Submission on 21 August 2019 by 14:00 hours IST, Bidders shall submit the originals (hard copies) of the following:

- a non-refundable Bid Document Fee of INR 29,500/- equivalent USD (incl GST) by Demand Draft / Banker's Cheque in favor of Superintending Engineer (HQ), PVVNL, Meerut, payable at Central Bank of India, in sealed cover in such a way that the envelope containing the Demand Draft is separately available for examination
- Bid Security in the amount and form as described in ITB Section-1 Clause-19 and Section-2 Clause-19.1.

9. The Employer will not responsible for any cost or expense incurred by Bidders in connection with the preparation or delivery of bids.

10. Technical bids shall be opened/downloaded on 21 August 2019 at 15:00 hours IST in the presence of the Bidders' representatives who choose to attend at the Pashchimanchal Vidyut Vitran Nigam Limited, Urja Bhawan, Victoria Park, Meerut, Uttar Pradesh PIN-250001.
