

## Invitation for Bids

1. The Government of India has applied for financing from the Asian Development Bank (ADB) towards the cost of **Uttar Pradesh Power Distribution Rehabilitation Project (UPDRP)**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Madhyanchal Vidyut Vitran Nigam Ltd, Lucknow** (MVVNL the “Employer”) invites online bids from eligible Bidders for the below-mentioned contract package:

3. **Open Competitive Bidding – International** will be conducted in accordance with ADB’s Single-Stage: Two-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.

The Bidders are required to review the eligibility criteria as mentioned in the section 3 of Bidding Documents and make an informed decision on their eligibility to qualify for the submission of the bid and the need to form a joint venture with another party if a Bidder does not meet the qualification criteria as a single entity. Bidders are required to submit only Bid Document Fee and Bid Security in hard copy on or before scheduled deadline for submission of bids.

On or before the time of Bid Submission on 24 July 2019 by 15:00 hours IST, Bidders shall

submit the originals (hard copies) of the following:
