1. The Government of India has applied a loan from Asian Development Bank (ADB) toward the cost of **Assam Road Network Improvement Project**. Part of the loan will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.

2. The **Public Works (Roads) Department, Government of Assam** (“the Employer”) invites bids from eligible Bidders for the construction and completion of the following works given in the table below:
