The Government of India has applied for financing from the Asian Development Bank (ADB) toward the cost of **Nagpur Metro Urban Mobility Project** and intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible countries of ADB.
2. The **Executive Director (Procurement), Maharashtra Metro Rail Corporation Limited**, invites sealed bids from eligible Bidders for **the Design, supply, installation, testing and commissioning of 25kV flexible OHE and sectioning posts for Nagpur Metro Rail Project Phase-2**. The brief description of the Works is mentioned below:

3. **Open competitive bidding (international advertisement)** will be conducted in accordance with the ADB's [Single Stage – Two Envelope](#) bidding procedure and is open to all eligible Bidders as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - **Technical Capacity:** the Bidder, since 1 January 2018, should not have non-performance of contract record and should declare any civil work contracts that have been suspended or terminated and/or performance security called by an employer for reasons related to the non-compliance of any environmental, or social and contractual obligations in the past five (5) financial years.
 - **Construction Experience:** the Bidder shall have minimum of similar work contracts (1 to 3 substantially completed metro rail or high-speed rail system contract), as a lead firm or as a JV member during the last ten (10) years.
 - **Financial Situation:** the Bidder shall have higher bid capacity than approximate cost of work; net worth should be minimum INR 70 Crores; positive profit after tax for any two year out of five consecutive years; and must meet minimum annual average construction turnover of INR 125 Crores within the last five (5) years.

For the complete eligibility and qualification requirements, bidders should refer to the bidding document.
