

## Invitation for Bids

1. The Joint Stock Company (JSC) “NK “Kazavtozhol” has applied a loan from the Asian Development Bank (ADB) toward the cost of **Central Asia Regional Economic Cooperation Corridors 1 and 6 Connector Road (Aktobe–Kandyagash) Reconstruction Project**. Part of this financing will be used for payments under the Contracts named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Joint Stock Company (JSC) “NK “Kazavtozhol”** (“the Employer”) invites sealed bids from eligible Bidders for the Lot 1 or Lot 2 or both lots. The Works comprise earthworks, bridges, asphaltic concrete pavements, and road furniture. The contracts period will be 930 days (Lot 1) and 990 days (Lot 2).
3. **Open Competitive Bidding** (international advertisement) will be conducted in accordance with ADB’s Single-Stage: Two Envelope bidding procedure for Plants and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding (should a Bidder be a Joint Venture, the way how the below mentioned criteria will be applied is further detailed in the Bidding Documents):

### Financial Situation

- The Bidder’s net worth for the last year calculated as the difference between total assets and total liabilities should be positive.
- Bidder’s minimum average annual construction turnover of USD 94 million (Lot 1) and USD 52 million (Lot 2) calculated as total certified payments received for contracts in progress or completed within the last three (3) years
- Bidder must demonstrate that its financial resources less its financial obligations for its current monthly contract commitments meet or exceed the total requirement for the Lot 1: USD 11.7 million, and Lot 2: 6.5 million

### Construction Experience

Participation as a contractor, JV partner, or subcontractor, in two (2) contracts that have been successfully or substantially completed within the last five (5) years and that are similar to the proposed works, where the value of the Bidder’s participation exceeds USD 85 million (Lot 1)

or USD 50 million (Lot 2). The similarity of the Bidder's participation shall be based on: the physical size and nature of works (e.g., earthworks, bridges, and pavement construction), complexity, methods, technology or other characteristics as detailed in the Bill of Quantities, and on the drawings included in Section 6 of the Bidding Documents, Employer's Requirements. Qualification criteria also include requirements on construction experience in specific key activities that are further detailed in Section 3 (Table 2.4.2) of the Bidding Document.
