1. The Kyrgyz Republic has received financing from the Asian Development Bank (ADB) towards the cost of Skills for Inclusive Growth Sector Development Program. Part of this financing will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB.

2. The Ministry of Education and Science of the Kyrgyz Republic (“the Purchaser”) invites sealed bids from eligible bidders for Procurement of Workshop/Training Equipment for 8 Centers of Excellence, Training Equipment for 10 Partner Institutions. The bidding covers three (3) lots:

- **Lot 1. Workshop and training equipment power/electric and veterinary.**
- **Lot 2. Workshop and training equipment production and processing technologies.**
- **Lot 3. Workshop and training equipment sewing, transport and auto.**

3. The Bidders can bid for any single lot, or a combination of lots, and consequently the Purchaser will evaluate and compare bids on the basis of a lot, or a combination of lots, or as a total of lots to arrive at the least cost combination for the Purchaser by taking into account discounts offered by Bidders in case of award of multiple contracts.

4. Open competitive bidding (international advertisement) will be conducted in accordance with ADB’s Single-Stage: One-Envelope bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

5. Only eligible bidders with the following key qualifications should participate in this bidding:

- (a) Minimum average annual turnover of calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years:
 - Lot 1: USD 1,430,000.00
 - Lot 2: USD 1,250,000.00
 - Lot 3: UDS 1,550,000.00
- (b) Successful completion as main supplier within the last five (5) years of at least two (2) contract with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply), valued at:

- Lot 1: USD 570,000.00
- Lot 2: USD 500,000.00
- Lot 3: UDS 620,000.00

The qualification criteria, also for Multiple Lots, are more completely described in the Bidding Documents.
