1. The Kyrgyz Republic has received financing from Asian Development Bank (ADB) toward the cost of **Strengthening Education System Sector Development Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Ministry of Education and Science of the Kyrgyz Republic** (the Purchaser), invites sealed bids from eligible Bidders for **Procurement of office equipment and classroom facilities for 30 innovative secondary schools and 7 TTIs in the Kyrgyz Republic** (the Goods).

3. **National Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the bidding documents.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- a) Minimum average annual turnover of **24 000 000 KGS**, calculated as total payments received by the Bidder for contracts completed or under execution over the last 3 (three) years;
- b) Successful completion as main supplier within the last 3 (three) years, of at least 2 (two) contracts each valued at **19 000 000 KGS** with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply) of bidding documents.
